1.8	Subdivision 1. Definitions. (a) For the purposes of this section, the following terms				
1.9	have the meanings given.				
1.10	(b) "Qualified small business" means a business that has been certified by the				
1.11	commissioner under subdivision 2.				
1.12	(c) "Qualified investor" means an investor who has been certified by the				
1.13	commissioner under subdivision 3.				
1.14	(d) "Qualified fund" means a pooled angel investment network fund that has been				
1.15	certified by the commissioner under subdivision 4.				
1.16	(e) "Qualified investment" means a cash investment in a qualified small business				
1.17	of a minimum of:				
1.18	(1) \$10,000 in a calendar year by a qualified investor; or				
1.19	(2) \$30,000 in a calendar year by a qualified fund.				
1.20	A qualified investment must be made in exchange for common stock, a partnership

2.12 EFFECTIVE DATE. This section is effective for qualified small businesses 2.13 certified after June 30, 2013.

Sec. 2. Minnesota Statutes 2012, section 116J.8737, subdivision 2, is amended to read: 2.14 Subd. 2. Certification of qualified small businesses. (a) Businesses may apply 2.15 to the commissioner for certification as a qualified small business for a calendar year. 2.16 The application must be in the form and be made under the procedures specified by the 2.17 commissioner, accompanied by an application fee of \$150. Application fees are deposited 2.18 in the small business investment tax credit administration account in the special revenue 2.19 fund. The application for certification for 2010 must be made available on the department's 2.20 Web site by August 1, 2010. Applications for subsequent years' certification must be made 2.21 available on the department's Web site by November 1 of the preceding year. 2.22

(b) Within 30 days of receiving an application for certification under this subdivision, 2.23 the commissioner must either certify the business as satisfying the conditions required of a 2.24 qualified small business, request additional information from the business, or reject the 2.25 application for certification. If the commissioner requests additional information from the 2.26 business, the commissioner must either certify the business or reject the application within 2.27 30 days of receiving the additional information. If the commissioner neither certifies the 2.28 business nor rejects the application within 30 days of receiving the original application or 2.29 within 30 days of receiving the additional information requested, whichever is later, then 2.30 the application is deemed rejected, and the commissioner must refund the \$150 application 2.31 fee. A business that applies for certification and is rejected may reapply. 2.32 (c) To receive certification, a business must satisfy all of the following conditions:

Sec. 3. Minnesota Statutes 2012, section 116J.8737, subdivision 5, is amended to read: 4.24 Subd. 5. Credit allowed. (a) A qualified investor or qualified fund is eligible for 4.25 a credit equal to 25 percent of the qualified investment in a qualified small business. 4.26 Investments made by a pass-through entity qualify for a credit only if the entity is a 4.27 qualified fund. The commissioner must not allocate more than \$11,000,000 in credits to 4.28 qualified investors or qualified funds for taxable years beginning after December 31, 2009, 4.29 and before January 1, 2011, and must not allocate more than \$12,000,000 in credits per 4.30 year for taxable years beginning after December 31, 2010, and before January 1, 2013, 4.31 or more than \$20,000,000 in credits per taxable year for taxable years beginning after 4.32 December 31, 2012, and before January 1, 2015. Any portion of a taxable year's credits 4.33 that is not allocated by the commissioner does not cancel and may be carried forward to 4.34 subsequent taxable years until all credits have been allocated. 4.35

- (b) The commissioner may not allocate more than a total maximum amount in credits
 for a taxable year to a qualified investor for the investor's cumulative qualified investments

- (c) The commissioner may not allocate a credit to a qualified investor either as an 5.7 individual qualified investor or as an investor in a qualified fund if the investor receives 58 more than 50 percent of the investor's gross annual income from the qualified small 5.9 business in which the qualified investment is proposed. A member of the family of an 5.10 individual disqualified by this paragraph is not eligible for a credit under this section. For 5.11 a married couple filing a joint return, the limitations in this paragraph apply collectively 5.12 to the investor and spouse. For purposes of determining the ownership interest of an 5.13 investor under this paragraph, the rules under section 267(c) and 267(e) of the Internal 5.14 Revenue Code apply. 5.15
- (d) Applications for tax credits for 2010 must be made available on the department's
 Web site by September 1, 2010, and the department must begin accepting applications
 by September 1, 2010. Applications for subsequent years must be made available by
 November 1 of the preceding year.
- (e) Qualified investors and qualified funds must apply to the commissioner for tax 5.20 credits. Tax credits must be allocated to qualified investors or qualified funds in the order 5.21 that the tax credit request applications are filed with the department. The commissioner 5.22 5.23 must approve or reject tax credit request applications within 15 days of receiving the application. The investment specified in the application must be made within 60 days of 5.24 the allocation of the credits. If the investment is not made within 60 days, the credit 5.25 allocation is canceled and available for reallocation. A qualified investor or qualified fund 5.26 that fails to invest as specified in the application, within 60 days of allocation of the 5.27 credits, must notify the commissioner of the failure to invest within five business days of 5.28 the expiration of the 60-day investment period. 5.29
- (f) All tax credit request applications filed with the department on the same day must
 be treated as having been filed contemporaneously. If two or more qualified investors or
 qualified funds file tax credit request applications on the same day, and the aggregate
 amount of credit allocation claims exceeds the aggregate limit of credits under this section
 or the lesser amount of credits that remain unallocated on that day, then the credits must
 be allocated among the qualified investors or qualified funds who filed on that day on a
 pro rata basis with respect to the amounts claimed. The pro rata allocation for any one

qualified investor or qualified fund is the product obtained by multiplying a fraction,
the numerator of which is the amount of the credit allocation claim filed on behalf of
a qualified investor and the denominator of which is the total of all credit allocation
claims filed on behalf of all applicants on that day, by the amount of credits that remain
unallocated on that day for the taxable year.

(g) A qualified investor or qualified fund, or a qualified small business acting on their 6.6 behalf, must notify the commissioner when an investment for which credits were allocated 6.7 has been made, and the taxable year in which the investment was made. A qualified fund 68 must also provide the commissioner with a statement indicating the amount invested by 6.9 each investor in the qualified fund based on each investor's share of the assets of the 6.10 qualified fund at the time of the qualified investment. After receiving notification that the 6.11 investment was made, the commissioner must issue credit certificates for the taxable year 6.12 in which the investment was made to the qualified investor or, for an investment made by 6.13 a qualified fund, to each qualified investor who is an investor in the fund. The certificate 6.14 must state that the credit is subject to revocation if the qualified investor or qualified 6.15 fund does not hold the investment in the qualified small business for at least three years, 6.16 consisting of the calendar year in which the investment was made and the two following 6.17 years.
