

A bill for an act relating to transportation finance; appropriating money for transportation, Metropolitan Council, and public safety activities and programs; providing for fund transfers and tort claims; authorizing an account and certain contingent appropriations; modifying previous appropriations provisions; modifying various provisions related to transportation finance and policy; modifying provisions related to speed limits, fracture-critical bridges, transit, passenger rail, motor vehicle lease sales tax revenue allocations, and transit services; requiring reports; amending Minnesota Statutes 2008, sections 161.081, by adding a subdivision; 161.36, subdivision 7, as added; 162.12, subdivision 2; 169.14, by adding a subdivision; 174.24, subdivision 1a, by adding a subdivision; 174.50, by adding a subdivision; 297A.815, subdivision 3; 473.408, by adding a subdivision; Laws 2007, chapter 143, article 1, section 3, subdivision 2, as amended; Laws 2008, chapter 152, article 1, section 5; proposing coding for new law in Minnesota Statutes, chapters 161; 174.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

25.30 resources for use by local governments and the Metropolitan Council to identify land use
25.31 and transportation planning strategies and processes to support the reduction of greenhouse
25.32 gas emissions through the reduction of per capita vehicle miles driven. The resources must
25.33 take into account recent transportation trends, including travel and demographic trends

26.1 specific to the Twin Cities Metropolitan Area. The Center for Transportation Studies shall
26.2 identify and use existing information and models to the extent they are useful and accurate.
26.3 The Center for Transportation Studies shall collaborate with the Metropolitan Council and
26.4 local units of government interested in development and refinement of the resources.
26.5 (c) By January 15, 2011, the Center for Transportation Studies shall submit a
26.6 report on the resources and findings to the chairs and ranking minority members of the
26.7 house of representatives and senate committees having jurisdiction over transportation
26.8 policy and finance.
