1.10	Section 1. Minnesota Statutes 2016, section 204B.14, subdivision 2, is amended to read:
1.11	Subd. 2. Separate precincts; combined polling place. (a) The following shall constitute
1.12	at least one election precinct:
1.13	(1) each city ward; and
1.14	(2) each town and each statutory city.
1.15	(b) A single, accessible, combined polling place may be established no later than
1.16	November 1 if a presidential nomination primary is scheduled to occur in the following

Subject to the requirements of paragraph (c), a single, accessible, combined polling place
may be established after May 1 of any year in the event of an emergency.

A copy of the ordinance or resolution establishing a combined polling place must be 2.4 2.5 filed with the county auditor within 30 days after approval by the governing body. A polling place combined under clause (3) must be approved by the governing body of each 2.6 participating municipality. A polling place combined under clause (4) must be approved by 27 the governing body of each participating municipality and the secretary of state and may 2.8 be located outside any of the noncontiguous precincts. A municipality withdrawing from 2.9 participation in a combined polling place must do so by filing a resolution of withdrawal 2.10 with the county auditor no later than October 1 if a presidential nomination primary is 2.11 scheduled to occur in the following year or April February 1 of any other year. 2.12

The secretary of state shall provide a separate polling place roster for each precinct 2.13 served by the combined polling place, except that in a precinct that uses electronic rosters 2.14 the secretary of state shall provide separate data files for each precinct. A single set of 2.15 election judges may be appointed to serve at a combined polling place. The number of 2.16 election judges required must be based on the total number of persons voting at the last 2.17 similar election in all precincts to be voting at the combined polling place. Separate ballot 2.18 boxes must be provided for the ballots from each precinct. The results of the election must 2.19 be reported separately for each precinct served by the combined polling place, except in a 2.20 polling place established under clause (2) where one of the precincts has fewer than ten 2.21 registered voters, in which case the results of that precinct must be reported in the manner 2.22 specified by the secretary of state. 2.23

(c) If a local elections official determines that an emergency situation preventing the
safe, secure, and full operation of a polling place on election day has occurred or is imminent,
the local elections official may combine two or more polling places for that election pursuant
to this subdivision. To the extent possible, the polling places must be combined and the
election conducted according to the requirements of paragraph (b), except that:

2.29 (1) polling places may be combined after May 1 and until the polls close on election2.30 day;

2.31 (2) any city or town, regardless of size or location, may establish a combined polling
2.32 place under this paragraph;

Subdivision 1. Appointment lists; duties of political parties and secretary of state. 3.20 On May March 1 in a year in which there is an election for a partisan political office, each 3.21 major political party shall prepare a list of eligible voters to act as election judges in each 3.22 election precinct. The political parties shall furnish the lists electronically to the secretary 3.23 of state, in a format specified by the secretary of state. The secretary of state must combine 3.24 the data received from each political party under this subdivision and must process the data 3.25 to locate the precinct in which the address provided for each potential election judge is 3.26 located. If the data submitted by a political party is insufficient for the secretary of state to 3.27 3.28 locate the proper precinct, the associated name must not appear in any list forwarded to an appointing authority under this subdivision. The secretary of state shall notify political 3.29 parties of any proposed election judges with addresses that could not be located in a precinct. 3.30
