Laws 1991, chapter 291, article 8, section 27, subdivision 3, as amended by 1.7 Laws 1998, chapter 389, article 8, section 28, Laws 2008, chapter 366, article 7, section 9, 18 and Laws 2009, chapter 88, article 4, section 14, is amended to read: 1.9 Subd. 3. Use of revenues. (a) Revenues received from taxes authorized by 1.10 subdivisions 1 and 2 shall be used by the city to pay the cost of collecting the tax and to 1 11 pay all or a portion of the expenses of constructing and improving facilities as part of an 1.12 urban revitalization project in downtown Mankato known as Riverfront 2000. Authorized 1.13 expenses include, but are not limited to, acquiring property and paying relocation expenses 1.14 related to the development of Riverfront 2000 and related facilities, and securing or paying 1.15 debt service on bonds or other obligations issued to finance the construction of Riverfront 1.16 2000 and related facilities. For purposes of this section, "Riverfront 2000 and related 1 17 facilities" means a civic-convention center, an arena, a riverfront park, a technology center 1.18 and related educational facilities, and all publicly owned real or personal property that 1 19 the governing body of the city determines will be necessary to facilitate the use of these 1 20 facilities, including but not limited to parking, skyways, pedestrian bridges, lighting, and 1.21 landscaping. It also includes the performing arts theatre and the Southern Minnesota 1.22 Women's Hockey Exposition Center, for use by Minnesota State University, Mankato. 1.23 (b) Notwithstanding section 297A.99, subdivision 3, and subject to voter approval 1.24 at a special or general election held on or before December 31, 2016, the city may by 1.25
