1.5	Section 1. "GETTING TO WORK" GRANT PROGRAM.
1.6	Subdivision 1. Creation. The commissioner of employment and economic
1.7	development shall make grants to nonprofit organizations to establish and operate
1.8	programs under this section that provide, repair, or maintain motor vehicles to assist
1.9	eligible individuals to obtain or maintain employment.
