BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2016, section 13.32, subdivision 1, is amended to read:

Subdivision 1. **Definitions.** As used in this section:

(a) "Educational data" means data on individuals which relate to a student and are maintained by a public educational agency or institution or by a person acting for or contracting with the agency or institution which relates to a student, including, but not limited to, a technology provider.

Records of instructional personnel which are in the sole possession of the maker thereof and are not accessible or revealed to any other individual except a substitute teacher, and are destroyed at the end of the school year, shall not be deemed to be government data.

Records of a law enforcement unit of a public educational agency or institution which are maintained apart from education data and are maintained solely for law enforcement purposes, and are not disclosed to individuals other than law enforcement officials of the jurisdiction are not educational data; provided, that education records maintained by the educational agency or institution are not disclosed to the personnel of the law enforcement unit. The University of Minnesota police department is a law enforcement agency for purposes of section 13.82 and other sections of Minnesota Statutes dealing with law enforcement records. Records of organizations providing security services to a public educational agency or institution must be administered consistent with section 13.861.

2.10	or institution, acting independently or with a technology provider, provides to an individual
2.11	student for that student's dedicated personal use. A school-issued device includes a device
2.12	issued through a one-to-one program.
2.13	(e) (e) "Student" means an individual currently or formerly enrolled or registered,
2.14	applicants for enrollment or registration at a public educational agency or institution, or
2.15	individuals who receive shared time educational services from a public agency or institution.
2.16	(d) (f) "Substitute teacher" means an individual who performs on a temporary basis the
2.17	duties of the individual who made the record, but does not include an individual who
2.18	permanently succeeds to the position of the maker of the record.
2.19	(g) "Technology provider" means a person who:
2.20	(1) contracts with a public educational agency or institution, as part of a one-to-one
2.21	program or otherwise, to provide technological devices for student use or to provide access
2.22	to a software or online application; and
2.23	(2) creates, receives, or maintains educational data pursuant or incidental to a contract

public educational agency or institution all educational data created, received, or maintained

4.3	(e) A technology provider must not sell, share, or disseminate educational data, except
4.4	as provided by this section or as part of a valid delegation or assignment of its contract with
4.5	a public educational agency or institution. An assignee or delegee that creates, receives, or
4.6	maintains educational data is subject to the same restrictions and obligations under this
4.7	section as the technology provider.
4.8	(f) A technology provider must not use educational data for any commercial purpose,
4.9	including, but not limited to, marketing or advertising to a student or parent.
4.10	(g) A technology provider must establish written procedures to ensure appropriate
4.11	security safeguards for educational data. These procedures must require that:
4.12	(1) the technology provider's employees or contractors have access to educational data
4.13	only if authorized;
4.14	(2) the technology provider's employees or contractors may be authorized to access
4.15	educational data only if access is necessary to fulfill the official duties of the employee or
4.16	contractor; and
4.17	(3) all actions in which educational data are entered, updated, accessed, shared, or
4.18	disseminated, are recorded in a log-of-use that includes the identity of the employee or
4.19	contractor interacting with the data.
4.20	These written procedures are public data unless classified as not public under any other
4.21	applicable law.
4.22	(h) A public educational agency or institution must annually give parents and students
4.23	direct, timely notice, by United States mail, e-mail, or other direct form of communication,
4.24	of any technology provider contract affecting a student's educational data. The notice must:
4.25	(1) identify each technology provider with access to educational data;
4.26	(2) identify the educational data affected by the technology provider contract; and
4.27	(3) include information about the contract inspection and opt-out rights provided in
4.28	paragraph (i).
4.29	(i) A public educational agency or institution must provide parents and students an

5.17	by paragraph (a) if:
5.18	(1) the student to whom the school-issued device was issued initiates and agrees to the
5.19	activity, and the activity is limited to a noncommercial educational purpose;
5.20	(2) the activity is permitted under a judicial warrant;
5.21	(3) the student to whom the school-issued device was provided or that student's parent
5.22	notifies the public educational agency or institution or law enforcement agency that the
5.23	device is missing or stolen; or
5.24	(4) the activity is necessary to respond to an imminent threat to life or safety and the
5.25	access is limited to that purpose.
5.26	(c) If a government entity or technology provider interacts with a school-issued device
5.27	as provided in paragraph (b), clause (4), it must, within 72 hours of the access, notify the
5.28	student to whom the device was provided or that student's parent and provide a written
5.29	description of the interaction, including which features of the device were accessed and a
5.30	description of the threat. This notice is not required if the notice itself would pose an
5.31	imminent threat to life or safety.
