1.2 relating to health; modifying provisions governing home care providers; amending
1.3 Minnesota Statutes 2018, sections 144A.43, subdivisions 11, 30, by adding a
1.4 subdivision; 144A.472, subdivisions 5, 7; 144A.473; 144A.474, subdivision 2;
1.5 144A.475, subdivisions 1, 2, 5; 144A.476, subdivision 1; 144A.479, subdivision
1.6 7; 144A.4791, subdivisions 1, 3, 6, 7, 8, 9; 144A.4792, subdivisions 1, 2, 5, 10;
1.7 144A.4793, subdivision 6; 144A.4796, subdivision 2; 144A.4797, subdivision 3;
1.8 144A.4798; 144A.4799, subdivisions 1, 3; 144A.484, subdivision 1; repealing

1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2018, section 144A.43, subdivision 11, is amended to read:

1.12 Subd. 11. **Medication administration.** "Medication administration" means performing
1.13 a set of tasks ~~to ensure a client takes medications, and includes~~ that include the following:

- 1.14 (1) checking the client's medication record;
- 1.15 (2) preparing the medication as necessary;
- 1.16 (3) administering the medication to the client;
- 1.17 (4) documenting the administration or reason for not administering the medication; and
- 1.18 (5) reporting to a registered nurse or appropriate licensed health professional any concerns
1.19 about the medication, the client, or the client's refusal to take the medication.

1.20 Sec. 2. Minnesota Statutes 2018, section 144A.43, is amended by adding a subdivision to
1.21 read:

1.22 Subd. 12a. **Medication reconciliation.** "Medication reconciliation" means the process
1.23 of identifying the most accurate list of all medications the client is taking, including the

2.1 name, dosage, frequency, and route by comparing the client record to an external list of
2.2 medications obtained from the client, hospital, prescriber, or other provider.

2.3 Sec. 3. Minnesota Statutes 2018, section 144A.43, subdivision 30, is amended to read:

2.4 Subd. 30. **Standby assistance.** "Standby assistance" means the presence of another
2.5 person ~~within arm's reach to minimize the risk of injury while performing daily activities~~
2.6 ~~through physical intervention or cueing~~ to assist a client with an assistive task by providing
2.7 cues, oversight, and minimal physical assistance.

2.8 Sec. 4. Minnesota Statutes 2018, section 144A.472, subdivision 5, is amended to read:

2.9 Subd. 5. ~~Transfers prohibited; Changes in ownership.~~ Any (a) A home care license
2.10 issued by the commissioner may not be transferred to another party. Before acquiring
2.11 ownership of or a controlling interest in a home care provider business, a prospective
2.12 applicant owner must apply for a new temporary license. A change of ownership is a transfer
2.13 of operational control to a different business entity of the home care provider business and
2.14 includes:

2.15 (1) transfer of the business to a different or new corporation;

2.16 (2) in the case of a partnership, the dissolution or termination of the partnership under
2.17 chapter 323A, with the business continuing by a successor partnership or other entity;

2.18 (3) relinquishment of control of the provider to another party, including to a contract
2.19 management firm that is not under the control of the owner of the business' assets;

2.20 (4) transfer of the business by a sole proprietor to another party or entity; or

2.21 (5) ~~in the case of a privately held corporation, the change in~~ transfer of ownership or
2.22 control of 50 percent or more of the outstanding voting stock controlling interest of a home
2.23 care provider business not covered by clauses (1) to (4).

2.24 (b) An employee who was employed by the previous owner of the home care provider
2.25 business prior to the effective date of a change in ownership under paragraph (a), and who
2.26 will be employed by the new owner in the same or a similar capacity, shall be treated as if
2.27 no change in employer occurred, with respect to orientation, training, tuberculosis testing,
2.28 background studies, and competency testing and training on the policies identified in
2.29 subdivision 1, clause (14), and subdivision 2, if applicable.

2.30 (c) Notwithstanding paragraph (b), a new owner of a home care provider business must
2.31 ensure that employees of the provider receive and complete training and testing on any

3.1 provisions of policies that differ from those of the previous owner within 90 days after the
 3.2 date of the change in ownership.

3.3 Sec. 5. Minnesota Statutes 2018, section 144A.472, subdivision 7, is amended to read:

3.4 Subd. 7. **Fees; application, change of ownership, and renewal.** (a) An initial applicant
 3.5 seeking temporary home care licensure must submit the following application fee to the
 3.6 commissioner along with a completed application:

3.7 (1) for a basic home care provider, \$2,100; or

3.8 (2) for a comprehensive home care provider, \$4,200.

3.9 (b) A home care provider who is filing a change of ownership as required under
 3.10 subdivision 5 must submit the following application fee to the commissioner, along with
 3.11 the documentation required for the change of ownership:

3.12 (1) for a basic home care provider, \$2,100; or

3.13 (2) for a comprehensive home care provider, \$4,200.

3.14 (c) For the period ending June 30, 2018, a home care provider who is seeking to renew
 3.15 the provider's license shall pay a fee to the commissioner based on revenues derived from
 3.16 the provision of home care services during the calendar year prior to the year in which the
 3.17 application is submitted, according to the following schedule:

4.4 (d) For the period between July 1, 2018, and June 30, 2020, a home care provider who
 4.5 is seeking to renew the provider's license shall pay a fee to the commissioner in an amount
 4.6 that is ten percent higher than the applicable fee in paragraph (c). A home care provider's
 4.7 fee shall be based on revenues derived from the provision of home care services during the
 4.8 calendar year prior to the year in which the application is submitted.

4.9 (e) Beginning July 1, 2020, a home care provider who is seeking to renew the provider's
 4.10 license shall pay a fee to the commissioner based on revenues derived from the provision
 4.11 of home care services during the calendar year prior to the year in which the application is
 4.12 submitted, according to the following schedule:

4.33 (f) If requested, the home care provider shall provide the commissioner information to
 4.34 verify the provider's annual revenues or other information as needed, including copies of
 4.35 documents submitted to the Department of Revenue.

5.1 (g) At each annual renewal, a home care provider may elect to pay the highest renewal
5.2 fee for its license category, and not provide annual revenue information to the commissioner.

5.3 (h) A temporary license or license applicant, or temporary licensee or licensee that
5.4 knowingly provides the commissioner incorrect revenue amounts for the purpose of paying
5.5 a lower license fee, shall be subject to a civil penalty in the amount of double the fee the
5.6 provider should have paid.

5.7 (i) The fee for failure to comply with the notification requirements of section 144A.473,
5.8 subdivision 2, paragraph (c), is \$1,000.

5.9 (j) Fees and penalties collected under this section shall be deposited in the state treasury
5.10 and credited to the state government special revenue fund. All fees are nonrefundable. Fees
5.11 collected under paragraphs (c), (d), and (e) are nonrefundable even if received before July
5.12 1, 2017, for temporary licenses or licenses being issued effective July 1, 2017, or later.

5.13 Sec. 6. Minnesota Statutes 2018, section 144A.473, is amended to read:

5.14 **144A.473 ISSUANCE OF TEMPORARY LICENSE AND LICENSE RENEWAL.**

5.15 Subdivision 1. **Temporary license and renewal of license.** (a) The department shall
5.16 review each application to determine the applicant's knowledge of and compliance with
5.17 Minnesota home care regulations. Before granting a temporary license or renewing a license,
5.18 the commissioner may further evaluate the applicant or licensee by requesting additional
5.19 information or documentation or by conducting an on-site survey of the applicant to
5.20 determine compliance with sections 144A.43 to 144A.482.

5.21 (b) Within 14 calendar days after receiving an application for a license, the commissioner
5.22 shall acknowledge receipt of the application in writing. The acknowledgment must indicate
5.23 whether the application appears to be complete or whether additional information is required
5.24 before the application will be considered complete.

5.25 (c) Within 90 days after receiving a complete application, the commissioner shall issue
5.26 a temporary license, renew the license, or deny the license.

5.27 (d) The commissioner shall issue a license that contains the home care provider's name,
5.28 address, license level, expiration date of the license, and unique license number. All licenses,
5.29 except for temporary licenses issued under subdivision 2, are valid for up to one year from
5.30 the date of issuance.

5.31 Subd. 2. **Temporary license.** (a) For new license applicants, the commissioner shall
5.32 issue a temporary license for either the basic or comprehensive home care level. A temporary

6.1 license is effective for up to one year from the date of issuance, except that a temporary
6.2 license may be extended according to subdivision 3. Temporary licensees must comply with
6.3 sections 144A.43 to 144A.482.

6.4 (b) During the temporary license year period, the commissioner shall survey the temporary
6.5 licensee within 90 calendar days after the commissioner is notified or has evidence that the
6.6 temporary licensee is providing home care services.

6.7 (c) Within five days of beginning the provision of services, the temporary licensee must
6.8 notify the commissioner that it is serving clients. The notification to the commissioner may
6.9 be mailed or e-mailed to the commissioner at the address provided by the commissioner. If
6.10 the temporary licensee does not provide home care services during the temporary license
6.11 year period, then the temporary license expires at the end of the year period and the applicant
6.12 must reapply for a temporary home care license.

6.13 (d) A temporary licensee may request a change in the level of licensure prior to being
6.14 surveyed and granted a license by notifying the commissioner in writing and providing
6.15 additional documentation or materials required to update or complete the changed temporary
6.16 license application. The applicant must pay the difference between the application fees
6.17 when changing from the basic level to the comprehensive level of licensure. No refund will
6.18 be made if the provider chooses to change the license application to the basic level.

6.19 (e) If the temporary licensee notifies the commissioner that the licensee has clients within
6.20 45 days prior to the temporary license expiration, the commissioner may extend the temporary
6.21 license for up to 60 days in order to allow the commissioner to complete the on-site survey
6.22 required under this section and follow-up survey visits.

6.23 **Subd. 3. Temporary licensee survey.** (a) If the temporary licensee is in substantial
6.24 compliance with the survey, the commissioner shall issue either a basic or comprehensive
6.25 home care license. If the temporary licensee is not in substantial compliance with the survey,
6.26 the commissioner shall either: (1) not issue a basic or comprehensive license and there will
6.27 be no contested hearing right under chapter 14. terminate the temporary license; or (2)
6.28 extend the temporary license for a period not to exceed 90 days and apply conditions, as
6.29 permitted under section 144A.475, subdivision 2, to the extension of a temporary license.
6.30 If the temporary licensee is not in substantial compliance with the survey within the time
6.31 period of the extension, or if the temporary licensee does not satisfy the license conditions,
6.32 the commissioner may deny the license.

6.33 (b) If the temporary licensee whose basic or comprehensive license has been denied or
6.34 extended with conditions disagrees with the conclusions of the commissioner, then the

7.1 temporary licensee may request a reconsideration by the commissioner or commissioner's
7.2 designee. The reconsideration request process must be conducted internally by the
7.3 commissioner or commissioner's designee, and chapter 14 does not apply.

7.4 (c) The temporary licensee requesting reconsideration must make the request in writing
7.5 and must list and describe the reasons why the temporary licensee disagrees with the decision
7.6 to deny the basic or comprehensive home care license or the decision to extend the temporary
7.7 license with conditions.

7.8 (d) The reconsideration request and supporting documentation must be received by the
7.9 commissioner within 15 calendar days after the date the temporary licensee receives the
7.10 correction order.

7.11 (e) A temporary licensee whose license is denied, is permitted to continue operating as
7.12 a home care provider during the period of time when:

7.13 (1) a reconsideration request is in process;

7.14 (2) an extension of a temporary license is being negotiated;

7.15 (3) the placement of conditions on a temporary license is being negotiated; or

7.16 (4) a transfer of home care clients from the temporary licensee to a new home care
7.17 provider is in process.

7.18 (f) A temporary licensee whose license is denied must comply with the requirements
7.19 for notification and transfer of clients in section 144A.475, subdivision 5.

7.20 Sec. 7. Minnesota Statutes 2018, section 144A.474, subdivision 2, is amended to read:

7.21 Subd. 2. **Types of home care surveys.** (a) "Initial full survey" means the survey of a
7.22 new temporary licensee conducted after the department is notified or has evidence that the
7.23 temporary licensee is providing home care services to determine if the provider is in
7.24 compliance with home care requirements. Initial full surveys must be completed within 14
7.25 months after the department's issuance of a temporary basic or comprehensive license.

7.26 (b) "Change in ownership survey" means a full survey of a new licensee due to a change
7.27 in ownership. Change in ownership surveys must be completed within six months after the
7.28 department's issuance of a new license due to a change in ownership.

7.29 (c) "Core survey" means periodic inspection of home care providers to determine ongoing
7.30 compliance with the home care requirements, focusing on the essential health and safety
7.31 requirements. Core surveys are available to licensed home care providers who have been
7.32 licensed for three years and surveyed at least once in the past three years with the latest

8.1 survey having no widespread violations beyond Level 1 as provided in subdivision 11.
8.2 Providers must also not have had any substantiated licensing complaints, substantiated
8.3 complaints against the agency under the Vulnerable Adults Act or Maltreatment of Minors
8.4 Act, or an enforcement action as authorized in section 144A.475 in the past three years.

8.5 (1) The core survey for basic home care providers must review compliance in the
8.6 following areas:

- 8.7 (i) reporting of maltreatment;
- 8.8 (ii) orientation to and implementation of the home care bill of rights;
- 8.9 (iii) statement of home care services;
- 8.10 (iv) initial evaluation of clients and initiation of services;
- 8.11 (v) client review and monitoring;
- 8.12 (vi) service plan implementation and changes to the service plan;
- 8.13 (vii) client complaint and investigative process;
- 8.14 (viii) competency of unlicensed personnel; and
- 8.15 (ix) infection control.

8.16 (2) For comprehensive home care providers, the core survey must include everything
8.17 in the basic core survey plus these areas:

- 8.18 (i) delegation to unlicensed personnel;
- 8.19 (ii) assessment, monitoring, and reassessment of clients; and
- 8.20 (iii) medication, treatment, and therapy management.

8.21 ~~(e)~~ (d) "Full survey" means the periodic inspection of home care providers to determine
8.22 ongoing compliance with the home care requirements that cover the core survey areas and
8.23 all the legal requirements for home care providers. A full survey is conducted for all
8.24 temporary licensees ~~and~~, for licensees that receive licenses due to an approved change in
8.25 ownership, for providers who do not meet the requirements needed for a core survey, and
8.26 when a surveyor identifies unacceptable client health or safety risks during a core survey.
8.27 A full survey must include all the tasks identified as part of the core survey and any additional
8.28 review deemed necessary by the department, including additional observation, interviewing,
8.29 or records review of additional clients and staff.

8.30 ~~(d)~~ (e) "Follow-up surveys" means surveys conducted to determine if a home care
8.31 provider has corrected deficient issues and systems identified during a core survey, full

9.1 survey, or complaint investigation. Follow-up surveys may be conducted via phone, e-mail,
9.2 fax, mail, or on-site reviews. Follow-up surveys, other than complaint surveys, shall be
9.3 concluded with an exit conference and written information provided on the process for
9.4 requesting a reconsideration of the survey results.

9.5 ~~(e)~~ (f) Upon receiving information alleging that a home care provider has violated or is
9.6 currently violating a requirement of sections 144A.43 to 144A.482, the commissioner shall
9.7 investigate the complaint according to sections 144A.51 to 144A.54.

9.8 Sec. 8. Minnesota Statutes 2018, section 144A.475, subdivision 1, is amended to read:

9.9 Subdivision 1. **Conditions.** (a) The commissioner may refuse to grant a temporary
9.10 license, refuse to grant a license as a result of a change in ownership, refuse to renew a
9.11 license, suspend or revoke a license, or impose a conditional license if the home care provider
9.12 or owner or managerial official of the home care provider:

9.13 (1) is in violation of, or during the term of the license has violated, any of the requirements
9.14 in sections 144A.471 to 144A.482;

9.15 (2) permits, aids, or abets the commission of any illegal act in the provision of home
9.16 care;

9.17 (3) performs any act detrimental to the health, safety, and welfare of a client;

9.18 (4) obtains the license by fraud or misrepresentation;

9.19 (5) knowingly made or makes a false statement of a material fact in the application for
9.20 a license or in any other record or report required by this chapter;

9.21 (6) denies representatives of the department access to any part of the home care provider's
9.22 books, records, files, or employees;

9.23 (7) interferes with or impedes a representative of the department in contacting the home
9.24 care provider's clients;

9.25 (8) interferes with or impedes a representative of the department in the enforcement of
9.26 this chapter or has failed to fully cooperate with an inspection, survey, or investigation by
9.27 the department;

9.28 (9) destroys or makes unavailable any records or other evidence relating to the home
9.29 care provider's compliance with this chapter;

9.30 (10) refuses to initiate a background study under section 144.057 or 245A.04;

9.31 (11) fails to timely pay any fines assessed by the department;

10.1 (12) violates any local, city, or township ordinance relating to home care services;

10.2 (13) has repeated incidents of personnel performing services beyond their competency
10.3 level; or

10.4 (14) has operated beyond the scope of the home care provider's license level.

10.5 (b) A violation by a contractor providing the home care services of the home care provider
10.6 is a violation by the home care provider.

10.7 Sec. 9. Minnesota Statutes 2018, section 144A.475, subdivision 2, is amended to read:

10.8 Subd. 2. **Terms to suspension or conditional license.** (a) A suspension or conditional
10.9 license designation may include terms that must be completed or met before a suspension
10.10 or conditional license designation is lifted. A conditional license designation may include
10.11 restrictions or conditions that are imposed on the provider. Terms for a suspension or
10.12 conditional license may include one or more of the following and the scope of each will be
10.13 determined by the commissioner:

10.14 (1) requiring a consultant to review, evaluate, and make recommended changes to the
10.15 home care provider's practices and submit reports to the commissioner at the cost of the
10.16 home care provider;

10.17 (2) requiring supervision of the home care provider or staff practices at the cost of the
10.18 home care provider by an unrelated person who has sufficient knowledge and qualifications
10.19 to oversee the practices and who will submit reports to the commissioner;

10.20 (3) requiring the home care provider or employees to obtain training at the cost of the
10.21 home care provider;

10.22 (4) requiring the home care provider to submit reports to the commissioner;

10.23 (5) prohibiting the home care provider from taking any new clients for a period of time;
10.24 or

10.25 (6) any other action reasonably required to accomplish the purpose of this subdivision
10.26 and section 144A.45, subdivision 2.

10.27 (b) A home care provider subject to this subdivision may continue operating during the
10.28 period of time home care clients are being transferred to other providers.

11.1 Sec. 10. Minnesota Statutes 2018, section 144A.475, subdivision 5, is amended to read:

11.2 Subd. 5. **Plan required.** (a) The process of suspending or revoking a license must include
11.3 a plan for transferring affected clients to other providers by the home care provider, which
11.4 will be monitored by the commissioner. Within three business days of being notified of the
11.5 final revocation or suspension action, the home care provider shall provide the commissioner,
11.6 the lead agencies as defined in section 256B.0911, and the ombudsman for long-term care
11.7 with the following information:

11.8 (1) a list of all clients, including full names and all contact information on file;

11.9 (2) a list of each client's representative or emergency contact person, including full names
11.10 and all contact information on file;

11.11 (3) the location or current residence of each client;

11.12 (4) the payor sources for each client, including payor source identification numbers; and

11.13 (5) for each client, a copy of the client's service plan, and a list of the types of services
11.14 being provided.

11.15 (b) The revocation or suspension notification requirement is satisfied by mailing the
11.16 notice to the address in the license record. The home care provider shall cooperate with the
11.17 commissioner and the lead agencies during the process of transferring care of clients to
11.18 qualified providers. Within three business days of being notified of the final revocation or
11.19 suspension action, the home care provider must notify and disclose to each of the home
11.20 care provider's clients, or the client's representative or emergency contact persons, that the
11.21 commissioner is taking action against the home care provider's license by providing a copy
11.22 of the revocation or suspension notice issued by the commissioner.

11.23 (c) A home care provider subject to this subdivision may continue operating during the
11.24 period of time home care clients are being transferred to other providers.

11.25 Sec. 11. Minnesota Statutes 2018, section 144A.476, subdivision 1, is amended to read:

11.26 Subdivision 1. **Prior criminal convictions; owner and managerial officials.** (a) Before
11.27 the commissioner issues a temporary license, issues a license as a result of an approved
11.28 change in ownership, or renews a license, an owner or managerial official is required to
11.29 complete a background study under section 144.057. No person may be involved in the
11.30 management, operation, or control of a home care provider if the person has been disqualified
11.31 under chapter 245C. If an individual is disqualified under section 144.057 or chapter 245C,
11.32 the individual may request reconsideration of the disqualification. If the individual requests

12.1 reconsideration and the commissioner sets aside or rescinds the disqualification, the individual
12.2 is eligible to be involved in the management, operation, or control of the provider. If an
12.3 individual has a disqualification under section 245C.15, subdivision 1, and the disqualification
12.4 is affirmed, the individual's disqualification is barred from a set aside, and the individual
12.5 must not be involved in the management, operation, or control of the provider.

12.6 (b) For purposes of this section, owners of a home care provider subject to the background
12.7 check requirement are those individuals whose ownership interest provides sufficient
12.8 authority or control to affect or change decisions related to the operation of the home care
12.9 provider. An owner includes a sole proprietor, a general partner, or any other individual
12.10 whose individual ownership interest can affect the management and direction of the policies
12.11 of the home care provider.

12.12 (c) For the purposes of this section, managerial officials subject to the background check
12.13 requirement are individuals who provide direct contact as defined in section 245C.02,
12.14 subdivision 11, or individuals who have the responsibility for the ongoing management or
12.15 direction of the policies, services, or employees of the home care provider. Data collected
12.16 under this subdivision shall be classified as private data on individuals under section 13.02,
12.17 subdivision 12.

144A.45 REGULATION OF HOME CARE SERVICES.

Subd. 6. **Home care providers; tuberculosis prevention and control.** (a) A home care provider must establish and maintain a comprehensive tuberculosis infection control program according to the most current tuberculosis infection control guidelines issued by the United States Centers for Disease Control and Prevention (CDC), Division of Tuberculosis Elimination, as published in CDC's Morbidity and Mortality Weekly Report (MMWR). This program must include a tuberculosis infection control plan that covers all paid and unpaid employees, contractors, students, and volunteers. The Department of Health shall provide technical assistance regarding implementation of the guidelines.

(b) Written compliance with this subdivision must be maintained by the home care provider.

144A.481 HOME CARE LICENSING IMPLEMENTATION FOR NEW LICENSEES AND TRANSITION PERIOD FOR CURRENT LICENSEES.

Subdivision 1. **Temporary home care licenses and changes of ownership.** (a) Beginning January 1, 2014, all temporary license applicants must apply for either a temporary basic or comprehensive home care license.

(b) Temporary home care licenses issued beginning January 1, 2014, shall be issued according to sections 144A.43 to 144A.4798, and the fees in section 144A.472. Temporary licensees must comply with the requirements of this chapter.

(c) No temporary license applications will be accepted nor temporary licenses issued between December 1, 2013, and December 31, 2013.

(d) Beginning October 1, 2013, changes in ownership applications will require payment of the new fees listed in section 144A.472. Providers who are providing nursing, delegated nursing, or professional health care services, must submit the fee for comprehensive home care providers, and all other providers must submit the fee for basic home care providers as provided in section 144A.472. Change of ownership applicants will be issued a new home care license based on the licensure law in effect on June 30, 2013.

Subd. 2. **Current home care licensees with licenses as of December 31, 2013.** (a) Beginning July 1, 2014, department licensed home care providers must apply for either the basic or comprehensive home care license on their regularly scheduled renewal date.

(b) By June 30, 2015, all home care providers must either have a basic or comprehensive home care license or temporary license.

Subd. 3. **Renewal application of home care licensure during transition period.** (a) Renewal and change of ownership applications of home care licenses issued beginning July 1, 2014, will be issued according to sections 144A.43 to 144A.4798 and, upon license renewal or issuance of a new license for a change of ownership, providers must comply with sections 144A.43 to 144A.4798. Prior to renewal, providers must comply with the home care licensure law in effect on June 30, 2013.

(b) The fees charged for licenses renewed between July 1, 2014, and June 30, 2016, shall be the lesser of 200 percent or \$1,000, except where the 200 percent or \$1,000 increase exceeds the actual renewal fee charged, with a maximum renewal fee of \$6,625.

(c) For fiscal year 2014 only, the fees for providers with revenues greater than \$25,000 and no more than \$100,000 will be \$313 and for providers with revenues no more than \$25,000 the fee will be \$125.
