2.8 Section 1. **TRANSPORTATION APPROPRIATIONS.**

2.9 The sums shown in the columns marked "Appropriations" are appropriated to the agencies  
 2.10 and for the purposes specified in this article. The appropriations are from the trunk highway  
 2.11 fund, or another named fund, and are available for the fiscal years indicated for each purpose.  
 2.12 Amounts for "Total Appropriation" and sums shown in the corresponding columns marked  
 2.13 "Appropriations by Fund" are summary only and do not have legal effect. The figures "2020"  
 2.14 and "2021" used in this article mean that the appropriations listed under them are available  
 2.15 for the fiscal year ending June 30, 2020, or June 30, 2021, respectively. "The first year" is  
 2.16 fiscal year 2020. "The second year" is fiscal year 2021. "The biennium" is fiscal years 2020  
 2.17 and 2021. "C.S.A.H." is the county state-aid highway fund. "M.S.A.S." is the municipal  
 2.18 state-aid street fund. "H.U.T.D." is the highway user tax distribution fund.

7.13 The commissioner of transportation must  
 7.14 notify the chairs, ranking minority members,  
 7.15 and staff of the legislative committees with  
 7.16 jurisdiction over transportation finance of any  
 7.17 significant events that cause the estimates of  
 7.18 federal aid to change.

7.19 This appropriation is for the actual  
 7.20 construction, reconstruction, and improvement  
 7.21 of trunk highways, including design-build  
 7.22 contracts, internal department costs associated  
 7.23 with delivering the construction program,  
 7.24 consultant usage to support these activities,  
 7.25 and the cost of actual payments to landowners  
 7.26 for lands acquired for highway rights-of-way,  
 7.27 payment to lessees, interest subsidies, and  
 7.28 relocation expenses.

7.29 The commissioner may expend up to one-half  
 7.30 of one percent of the federal appropriations  
 7.31 under this paragraph as grants to opportunity  
 7.32 industrialization centers and other nonprofit

12.16 (a) With the approval of the commissioner of  
 12.17 management and budget, the commissioner  
 12.18 of transportation may transfer unencumbered  
 12.19 balances among the appropriations from the  
 12.20 trunk highway fund and the state airports fund  
 12.21 made in this section. Transfers under this  
 12.22 paragraph must not be made: (1) between  
 12.23 funds; (2) from the appropriations for state  
 12.24 road construction or debt service; or (3) from  
 12.25 the appropriations for operations and  
 12.26 maintenance or program delivery, except for  
 12.27 a transfer to state road construction or debt  
 12.28 service.

12.29 (b) The commissioner of transportation must

(b) When approaching and before passing a freeway service patrol vehicle, road maintenance vehicle, utility company vehicle, or construction vehicle with its warning lights activated that is parked or otherwise stopped on or next to a street or highway having more than two lanes in the same direction, the driver of a vehicle shall safely move the vehicle so as to leave a full lane vacant between the driver and any lane in which the vehicle is completely or partially parked or otherwise stopped, if it is possible to do so.

(c) If a lane change under paragraph (a) or (b) is impossible, or when approaching and before passing a freeway service patrol vehicle, road maintenance vehicle, utility company vehicle, or construction vehicle with its warning lights activated that is parked or otherwise stopped on or next to a street or highway having only one lane in the same direction, the driver of a vehicle must reduce the speed of the motor vehicle to a speed that is reasonable and prudent under the conditions until the motor vehicle has completely passed the parked or stopped freeway service patrol vehicle, road maintenance vehicle, utility company vehicle, or construction vehicle, if it is possible to do so.

The council must remove all references, other than references for historical purposes, to the Dan Patch commuter rail line from any future revisions to the council's transportation development guide and the council's regional transit master plan.

Subd. 3. **Commissioner of transportation.** The commissioner of transportation must not expend any money for study, planning, preliminary engineering, final design, or construction for the Dan Patch commuter rail line. The commissioner must remove all references, other than references for historical purposes, to the Dan Patch commuter rail line from any future revisions to the state transportation plan and the commissioner's commuter rail system plan.

Subd. 4. **Regional rail authorities.** No regional rail authority may expend any money for study, planning, preliminary engineering, final design, or construction for the Dan Patch commuter rail line.
