Within 14 37 days before election day, the official in charge of elections shall have the 11.3 voting system tested to ascertain that the system will correctly mark ballots using all methods 11.4 supported by the system, including through assistive technology, and count the votes cast 11.5 for all candidates and on all questions. Public notice of the time and place of the test must 11.6 be given at least two days in advance by publication once in official newspapers. The test 11.7 must be observed by at least two election judges, who are not of the same major political 11.8 party, and must be open to representatives of the political parties, candidates, the press, and 11.9 the public. The test must be conducted by (1) processing a preaudited group of ballots 11.10 punched or marked to record a predetermined number of valid votes for each candidate and 11.11 on each question, and must include for each office one or more ballot cards which have 11.12 votes in excess of the number allowed by law in order to test the ability of the voting system 11.13 tabulator and electronic ballot marker to reject those votes; and (2) processing an additional 11.14 test deck of ballots marked using the electronic ballot marker for the precinct, including 11.15 11.16 ballots marked using the electronic ballot display, audio ballot reader, and any assistive voting technology used with the electronic ballot marker. If any error is detected, the cause 11.17 must be ascertained and corrected and an errorless count must be made before the voting 11.18 system may be used in the election. #### 203B.081 LOCATIONS AND METHODS FOR ABSENTEE VOTING IN PERSON.

Subd. 3. Alternative procedure. (a) The county auditor may make available a ballot counter and ballot box for use by the voters during the seven days before the election. If a ballot counter and ballot box is provided, a voter must be given the option either (1) to vote using the process provided in section 203B.08, subdivision 1, or (2) to vote in the manner provided in this subdivision.

(b) If a voter chooses to vote in the manner provided in this subdivision, the voter must state the voter's name, address, and date of birth to the county auditor or municipal clerk. The voter shall sign a voter's certificate, which must include the voter's name, identification number, and the certification required by section 201.071, subdivision 1. The signature of an individual on the voter's certificate and the issuance of a ballot to the individual is evidence of the intent of the individual to vote at that election.

(c) After signing the voter's certificate, the voter shall be issued a ballot and immediately retire to a voting station or other designated location in the polling place to mark the ballot. The ballot must not be taken from the polling place. If the voter spoils the ballot, the voter may return it to the election official in exchange for a new ballot. After completing the ballot, the voter shall deposit the ballot into the ballot box.

(d) The election official must immediately record that the voter has voted in the manner provided in section 203B.121, subdivision 3.

(e) The election duties required by this subdivision must be performed by the county auditor, municipal clerk, or a deputy of the auditor or clerk.
