1.7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.8	Section 1. Minnesota Statutes 2012, section 524.2-803, is amended to read:
1.9	524.2-803 EFFECT OF HOMICIDE ON INTESTATE SUCCESSION, WILLS,
1.10	JOINT ASSETS, LIFE INSURANCE AND BENEFICIARY DESIGNATIONS;
1.11	EMERGENCY ORDER.
1.12	(a) A surviving spouse, heir or devisee who feloniously and intentionally kills the
1.13	decedent is not entitled to any benefits under the will or under this article, including an
1.14	intestate share, an elective share, an omitted spouse's or child's share, homestead, exempt
1.15	property, and a family allowance, and the estate of decedent passes as if the killer had
1.16	predeceased the decedent. Property appointed by the will of the decedent to or for the
1.17	benefit of the killer passes as if the killer had predeceased the decedent.
1.18	(b) Any joint tenant who feloniously and intentionally kills another joint tenant
1.19	thereby effects a severance of the interest of the decedent so that the share of the
1.20	decedent passes as the decedent's property and the killer has no rights by survivorship.
1.21	This provision applies to joint tenancies in real and personal property, joint accounts in
1.22	banks, savings associations, credit unions and other institutions, and any other form of
1.23	co-ownership with survivorship incidents.
1.24	(c) A named beneficiary of a bond or other contractual arrangement who feloniously

2.1 other contractual arrangement and it becomes payable as though the killer had predeceased2.2 the decedent.

(d) A named beneficiary of a life insurance policy who feloniously and intentionally 2.3 kills the person upon whose life the policy is issued is not entitled to any benefit under 2.4 the policy and the proceeds of the policy shall be paid and distributed by order of the 2.5 court as hereinafter provided. If a person who feloniously and intentionally kills a person 2.6 upon whose life a life insurance policy is issued is a beneficial owner as shareholder, 2.7 partner or beneficiary of a corporation, partnership, trust or association which is the named 28 beneficiary of the life insurance policy, to the extent of the killer's beneficial ownership of 2.9 the corporation, partnership, trust or association, the proceeds of the policy shall be paid 2.10 and distributed by order of the court as hereinafter provided. 2.11

Upon receipt of written notice by the insurance company at its home office that 2.12 the insured may have been intentionally and feloniously killed by one or more named 2.13 beneficiaries or that the insured may have been intentionally and feloniously killed by 2.14 one or more persons who have a beneficial ownership in a corporation, partnership, trust 2.15 or association, which is the named beneficiary of the life insurance policy, the insurance 2.16 company shall, pending court order, withhold payment of the policy proceeds to all 2.17 beneficiaries. In the event that the notice has not been received by the insurance company 2.18before payment of the policy proceeds, the insurance company shall be fully and finally 2.19 discharged and released from any and all responsibility under the policy to the extent 2.20 that the policy proceeds have been paid. 2.21

The named beneficiary, the insurance company or any other party claiming an 2.22 2.23 interest in the policy proceeds may commence an action in the district court to compel payment of the policy proceeds. The court may order the insurance company to pay 2.24 the policy proceeds to any person equitably entitled thereto, including the deceased 2.25 insured's spouse, children, issue, parents, creditors or estate, and may order the insurance 2.26 company to pay the proceeds of the policy to the court pending the final determination 2.27 of distribution of the proceeds by the court. The insurance company, upon receipt of a 2.28 court order, judgment or decree ordering payment of the policy proceeds, shall pay the 2.29 policy proceeds according to the terms of the order, and upon payment of such proceeds 2.30 according to the terms of the court order, shall be fully and completely discharged and 2.31 released from any and all responsibility for payment under the policy. 2.32

2.33 (e) Any other acquisition of property or interest by the killer shall be treated in2.34 accordance with the principles of this section.

2.35 (f) A final judgment of conviction of felonious and intentional killing is conclusive2.36 for purposes of this section. In the absence of a conviction of felonious and intentional

An order may be granted without notice to other interested persons if the court finds from 4.1 affidavit or other sworn testimony that the rights of decedent's heirs and beneficiaries may 4.2 be irreparably harmed before a hearing can be held. If an ex parte order is granted, notice 4.3 must be given to interested persons known by the court and as the court directs within 48 4.4 hours of issuing the order and the court shall hold a hearing within five days of issuing the 4.5 order. In all other cases, reasonable notice of the time and place of hearing on the petition 4.6 must be given to interested persons known by the court and as the court directs. An order 4.7 issued under this paragraph shall be effective pending a final determination under this 4.8

4.12 A special administrator may be appointed:

4.13 (1) informally by the registrar on the application of any interested person when
4.14 necessary to protect the estate of a decedent prior to the appointment of a general personal
4.15 representative, when necessary to protect the estate of a decedent due to circumstances
4.16 described in section 524.2-803, or if a prior appointment has been terminated as provided
4.17 in section 524.3-609;

4.18 (2) in a formal proceeding by order of the court on the petition of any interested
4.19 person and finding, after notice and hearing, that appointment is necessary to preserve the
4.20 estate or to secure its proper administration including its administration in circumstances
4.21 where a general personal representative cannot or should not act. If it appears to the
4.22 court that an emergency exists or that section 524.2-803 may apply, appointment may be
4.23 ordered without notice.

5.18	(c) A supplemental notice of the rights of crime victims must be distributed by the

5.20	is charged or petitioned. This notice must inform a victim of all the rights of crime victims

5.21 under this chapter.
