BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4

Section 1. Minnesota Statutes 2012, section 297E.02, subdivision 6, is amended to read: 1.5 Subd. 6. Combined net receipts tax. (a) In addition to the taxes imposed under 1.6 subdivision 1, a tax is imposed on the combined receipts of the organization. As used in 1.7 this section, "combined net receipts" is the sum of the organization's gross receipts from 1.8 lawful gambling less gross receipts directly derived from the conduct of paper bingo, 19 raffles, and paddle wheels, as defined in section 297E.01, subdivision 8, and less the net 1.10 prizes actually paid, other than prizes actually paid for paper bingo, raffles, and paddle 1.11 wheels, for the fiscal year. The combined net receipts of an organization are subject to a 1.12 tax computed according to the following schedule: 1.13

(b) On or before April 1, 2016, the commissioner shall estimate the total amount of 1.24 revenue, including interest and penalties, that will be collected for fiscal year 2016 from 1.25 taxes imposed under this chapter. If the amount estimated by the commissioner equals 1.26

2.1 or exceeds \$94,800,000, the commissioner shall certify that effective July 1, 2016, the

2.2 rates under this paragraph apply in lieu of the rates under paragraph (a) and shall publish a

2.3 notice to that effect in the State Register and notify each taxpayer by June 1, 2016. If the

2.17 (c) Gross receipts derived from sports-themed tipboards are exempt from taxation

2.18 under this section. For purposes of this paragraph, a sports-themed tipboard means a

2.20 winning numbers are determined by the numerical outcome of a professional sporting event.

2.21 (d) Organizations that conduct lawful gambling in a location where the primary

2.22 business is bingo are exempt from taxation under this subdivision.
