1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2012, section 297A.70, subdivision 2, is amended to read:
1.6	Subd. 2. Sales to government. (a) All sales, except those listed in paragraph (b),
1.7	to the following governments and political subdivisions, or to the listed agencies or
1.8	instrumentalities of governments and political subdivisions, are exempt:
1.9	(1) the United States and its agencies and instrumentalities;
1.10	(2) school districts, the University of Minnesota, state universities, community
1.11	colleges, technical colleges, state academies, the Perpich Minnesota Center for Arts
1.12	Education, and an instrumentality of a political subdivision that is accredited as an
1.13	optional/special function school by the North Central Association of Colleges and Schools;
1.14	(3) hospitals and nursing homes owned and operated by political subdivisions of
1.15	the state of tangible personal property and taxable services used at or by hospitals and
1.16	nursing homes;
1.17	(4) the Metropolitan Council, for its purchases of vehicles and repair parts to equip

2.4	(1) building, construction, or reconstruction materials purchased by a contractor
2.5	or a subcontractor as a part of a lump-sum contract or similar type of contract with a
2.6	guaranteed maximum price covering both labor and materials for use in the construction,
2.7	alteration, or repair of a building or facility;
2.8	(2) construction materials purchased by tax exempt entities or their contractors to

2.11	(3) the leasing of a motor vehicle as defined in section 297B.01, subdivision 11,

2.23	(d) As used in this subdivision, "goods or services generally provided by a private
2.24	business" include, but are not limited to, goods or services provided by liquor stores, gas
2.25	and electric utilities, golf courses, marinas, health and fitness centers, campgrounds, cafes,
2.26	and laundromats. "Goods or services generally provided by a private business" do not
2.27	include housing services, sewer and water services, wastewater treatment, ambulance and
2.28	other public safety services, correctional services, chore or homemaking services provided
2.29	to elderly or disabled individuals, or road and street maintenance or lighting.

2.30 EFFECTIVE DATE. This section is effective for sales and purchases made after 2.31 January 1, 2014.
