1.7	Subd. 7. Disbursement of surcharges by commissioner of management and budget.
1.8	(a) Except as provided in paragraphs (b), (c), and (d), the commissioner of management
1.9	and budget shall disburse surcharges received under subdivision 6 and section 97A.065,
1.10	subdivision 2, as follows:
1.11	(1) one percent shall <u>must</u> be credited to the peace officer training account in the game
1.12	and fish fund to provide peace officer training for employees of the Department of Natural
1.13	Resources who are licensed under sections 626.84 to 626.863, and who possess peace officer
1.14	authority for the purpose of enforcing game and fish laws;
