- (c) "Employer" means a person or entity that employs 20 or more employees at at least 2.1 one site and includes an individual, corporation, partnership, association, nonprofit 2.2 organization, group of persons, state, county, town, city, school district, or other governmental 2.3 subdivision. 2.4

Subd. 2. Paid leave. An employer must grant paid leaves of absence to an employee 2.5 who seeks to undergo a medical procedure to donate bone marrow or to donate an organ or 2.6 partial organ to another person. The combined length of the leaves shall be determined by 2.7 the employee, but may not exceed 40 work hours, unless agreed to by the employer. The 2.8 employer may require verification by a physician of the purpose and length of each leave 2.9 requested by the employee to donate for bone marrow or organ donation. If there is a medical 2.10 determination that the employee does not qualify as a bone marrow or organ donor, the paid 2.11 leave of absence granted to the employee prior to that medical determination is not forfeited. 2.12

Subd. 2a. Unpaid leave; organ donation. An employer must grant unpaid leaves of 2.13

absence to an employee who seeks to undergo a medical procedure to donate an organ or 2.14

partial organ to another person. The total length of leave under this subdivision and 2.15

subdivision 2 shall be determined by the employee, but must not exceed 12 weeks, unless 2.16 agreed to by the employer. 2.17

- Subd. 3. No employer sanctions. An employer shall not retaliate against an employee 2.18 for requesting or obtaining a leave of absence as provided by this section. 2.19
- Subd. 4. Relationship to other leave. This section does not prevent an employer from 2.20 providing leave for bone marrow or organ donations in addition to leave allowed under this 2.21 section. This section does not affect an employee's rights with respect to any other 2.22 employment benefit. 2.23

2.27 Subd. 6. Return to active firefighting after break in service. (a) This subdivision governs the service pension calculation requirements of a firefighter who returns to active 2.28 service after a break in service and applies to all breaks in service, except that the resumption 2.29 service requirements of this subdivision do not apply to leaves of absence made available 2.30 by federal statute, such as the Family Medical Leave Act, United States Code, title 29, 2.31 section 2691, and the Uniformed Services Employment and Reemployment Rights Act, 2.32 United States Code, title 38, section 4301, and do not apply to leaves of absence made 2.33

(b)(1) If a firefighter who has a break in service of any duration resumes performing
active firefighting with the fire department associated with the relief association, and if the
bylaws of the relief association so permit, the firefighter may again become an active member
of the relief association, subject to the requirements of this paragraph and the service pension
calculation requirements under this section.

3.11 (2) A firefighter who has been paid a service pension or disability benefit must wait at
3.12 least 60 days following receipt of the pension or benefit before resuming active firefighting
3.13 with the fire department and active membership in the relief association.

3.14 (3) A firefighter who has been granted an approved leave of absence not exceeding one
3.15 year by the fire department or by the relief association is exempt from the minimum period

If a lump-sum service pension had been paid to the firefighter 4.6 upon the firefighter's previous cessation of duties, a second lump-sum service pension for 4.7 the resumption service period must be calculated by applying the service pension amount 4.8 in effect on the date of the firefighter's termination of the resumption service for all years 4.9 of the resumption service. 4.10

(f) A firefighter who had not been paid a lump-sum service pension returns to active 4.11 relief association membership under paragraph (b), who did not meet the minimum period 4.12 of resumption service requirement specified in the relief association's bylaws, but who does 4.13 meet the minimum service requirement of section 424A.02, subdivision 2, based on the 4.14 firefighter's original and resumption years of active service, must have, upon a subsequent 4.15 cessation of duties, a service pension for the original and resumption service periods 4.16 calculated by applying the service pension amount in effect on the date of the firefighter's 4.17 termination of the resumption service, or, if the bylaws so provide, based on the service 4.18 pension amount in effect on the date of the firefighter's previous cessation of duties. The 4.19 service pension for a firefighter who returns to active lump-sum relief association membership 4.20 under this paragraph, but who had met the minimum period of resumption service requirement 4.21 specified in the relief association's bylaws, must be calculated by applying the service 4.22 pension amount in effect on the date of the firefighter's termination of the resumption service. 4.23

(g) If a firefighter receiving a monthly benefit service pension returns to active monthly 4.24 benefit relief association membership under paragraph (b), and if the relief association 4.25 bylaws do not allow for the firefighter to continue collecting a monthly service pension, 4.26 any monthly benefit service pension payable to the firefighter is suspended as of the first 4.27 day of the month next following the date on which the firefighter returns to active 4.28 membership. If the firefighter was receiving a monthly benefit service pension, and qualifies 4.29 for a service pension under paragraph (c), the firefighter is entitled to an additional monthly 4.30 benefit service pension upon a subsequent cessation of duties calculated based on the 4.31 resumption service credit and the service pension accrual amount in effect on the date of 4.32 the termination of the resumption service. A suspended initial service pension resumes as 4.33 of the first of the month next following the termination of the resumption service. If the 4.34 firefighter was not receiving a monthly benefit service pension and meets the minimum 4.35

service requirement of section 424A.02, subdivision 2, a service pension must be calculated
by applying the service pension amount in effect on the date of the firefighter's termination
of the resumption service for all years of service credit.

(h) A firefighter who was not receiving a monthly benefit service pension returns to 5.4 active relief association membership under paragraph (b), who did not meet the minimum 5.5 period of resumption service requirement specified in the relief association's bylaws, but 5.6 who does meet the minimum service requirement of section 424A.02, subdivision 2, based 5.7 on the firefighter's original and resumption years of active service, must have, upon a 5.8 subsequent cessation of duties, a service pension for the original and resumption service 5.9 periods calculated by applying the service pension amount in effect on the date of the 5.10 firefighter's termination of the resumption service, or, if the bylaws so provide, based on 5.11 the service pension amount in effect on the date of the firefighter's previous cessation of 5.12 duties. The service pension for a firefighter who returns to active relief association 5.13 membership under this paragraph, but who had met the minimum period of resumption 5.14 service requirement specified in the relief association's bylaws, must be calculated by 5.15 applying the service pension amount in effect on the date of the firefighter's termination of 5.16 the resumption service. 5.17

(i) For defined contribution plans, a firefighter who returns to active relief association 5.18 membership under paragraph (b) and who qualifies for a service pension under paragraph 5.19 (c) or (d) must have, upon a subsequent cessation of duties, any service pension for the 5.20 resumption service period calculated as a separate benefit. If a service pension had been 5.21 paid to the firefighter upon the firefighter's previous cessation of duties, and if the firefighter 5.22 meets the minimum service requirement of section 424A.016, subdivision 3, or meets the 5.23 resumption minimum service requirements specified in the relief association's bylaws, as 5.24 applicable, based on the resumption years of service, a second service pension for the 5.25 resumption service period must be calculated to include allocations credited to the firefighter's 5.26 individual account during the resumption period of service and deductions for administrative 5.27 expenses, if applicable. 5.28

(j) For defined contribution plans, if a firefighter who had not been paid a service pension
returns to active relief association membership under paragraph (b), and who meets the
minimum service requirement of section 424A.016, subdivision 3, based on the firefighter's
original and resumption years of service, must have, upon a subsequent cessation of duties,
a service pension for the original and resumption service periods calculated to include
allocations credited to the firefighter's individual account during the original and resumption

## APPENDIX Repealed Minnesota Statutes: H1741-1

## 181.9456 LEAVE FOR ORGAN DONATION.

Subdivision 1. **Definitions.** (a) For the purposes of this section, the following terms have the meanings given to them in this subdivision.

(b) "Employee" means a person who performs services for hire for a public employer, for an average of 20 or more hours per week, and includes all individuals employed at any site owned or operated by a public employer. Employee does not include an independent contractor.

(c) "Employer" means a state, county, city, town, school district, or other governmental subdivision that employs 20 or more employees.

Subd. 2. Leave. An employer must grant paid leaves of absence to an employee who seeks to undergo a medical procedure to donate an organ or partial organ to another person. The combined length of the leaves shall be determined by the employee, but may not exceed 40 work hours for each donation, unless agreed to by the employer. The employer may require verification by a physician of the purpose and length of each leave requested by the employee for organ donation. If there is a medical determination that the employee does not qualify as an organ donor, the paid leave of absence granted to the employee prior to that medical determination is not forfeited.

Subd. 3. No employer sanctions. An employer shall not retaliate against an employee for requesting or obtaining a leave of absence as provided by this section.

Subd. 4. **Relationship to other leave.** This section does not prevent an employer from providing leave for organ donations in addition to leave allowed under this section. This section does not affect an employee's rights with respect to any other employment benefit.
