7.4 \$10,280,000 the first year and \$16,875,000
7.5 the second year are to procure, implement,
7.6 and support advanced cybersecurity tools that
7.7 combat persistent and evolving cybersecurity
7.8 threats. This is a onetime appropriation and is
7.9 available until June 30, 2027.

7.10 **(c) Executive Branch Cloud**

7.11 **Transformation.** \$10,685,000 the first year
7.12 and \$22,910,000 the second year are to
7.13 support planning, migration, modernization,
7.14 infrastructure, training, and services required
7.15 for executive branch cloud transformation to
7.16 modernize enterprise information technology
7.17 delivery for state agency business partners.
7.18 This is a onetime appropriation and is
7.19 available until June 30, 2027.

7.20 **(d) Targeted Application Modernization.**

7.21 \$40,000,000 the first year is to modernize
7.22 targeted applications to improve user
7.23 experiences with digital services provided by
7.24 state agencies, enable service delivery
7.25 transformation, and systematically address
7.26 aging technology. This is a onetime
7.27 appropriation and is available until June 30,
7.28 2027.

7.29 **(e) Children's Cabinet IT Innovation.**

7.30 \$2,000,000 each year is to provide technology
7.31 capabilities that support centering Minnesota
7.32 children and their families over agency
7.33 structures and provides dedicated information
7.34 technology resources to deliver innovative
7.35 digital services to children and families. This

8.1 is a onetime appropriation and is available
8.2 until June 30, 2027.

8.3 (f) **Public Land Survey System. \$9,700,000**
8.4 the first year is for the grant program
8.5 authorized by Minnesota Statutes, section
8.6 381.125, and for grants to counties to employ
8.7 county technical staff to aid surveyors making
8.8 land survey corners. Up to six percent of this
8.9 appropriation may be used by the chief
8.10 geospatial information officer for the
8.11 administration of the grant program. This is a
8.12 onetime appropriation and is available until
8.13 June 30, 2027.

8.14 (g) During the biennium ending June 30, 2025,
8.15 the Department of Information Technology
8.16 Services must not charge fees to a public
8.17 noncommercial educational television
8.18 broadcast station eligible for funding under
8.19 Minnesota Statutes, chapter 129D, for access
8.20 to the state broadcast infrastructure. If the
8.21 access fees not charged to public
8.22 noncommercial educational television
8.23 broadcast stations total more than \$400,000

9.18 second year are for grants administration
9.19 oversight. The base for this appropriation in
9.20 fiscal year 2026 and each year thereafter is
9.21 \$1,581,000.

9.22 \$735,000 the first year and \$201,000 the
9.23 second year are for a study to develop a road
9.24 map on the need for an enterprise grants
9.25 management system and to implement the
9.26 study's recommendation. This is a onetime

10.29 The base for this appropriation is \$15,833,000
 10.30 in fiscal year 2026 and each fiscal year
 10.31 thereafter.

11.1 The appropriations under this section are to
11.2 the commissioner of administration for the
11.3 purposes specified.

11.4 **In-Lieu of Rent.** \$11,129,000 each year is for
11.5 space costs of the legislature and veterans
11.6 organizations, ceremonial space, and
11.7 statutorily free space.

11.8 **Public Television.** (a) \$1,550,000 each year
11.9 is for matching grants for public television.

11.10 (b) \$250,000 each year is for public television
11.11 equipment grants under Minnesota Statutes,
11.12 section 129D.13.

11.13 (c) \$500,000 each year is for block grants to
11.14 public television under Minnesota Statutes,
11.15 section 129D.13. Of this amount, up to three
11.16 percent is for the commissioner of
11.17 administration to administer the grants. This
11.18 is a onetime appropriation.

11.19 (d) The commissioner of administration must
11.20 consider the recommendations of the
11.21 Minnesota Public Television Association
11.22 before allocating the amounts appropriated in
11.23 paragraphs (a) and (b) for equipment or
11.24 matching grants.

11.25 **Public Radio.** (a) \$2,392,000 the first year
11.26 and \$1,242,000 the second year are for
11.27 community service grants to public
11.28 educational radio stations. This appropriation
11.29 may be used to disseminate emergency
11.30 information in foreign languages. Any
11.31 unencumbered balance does not cancel at the
11.32 end of the first year and is available for the
11.33 second year.

12.1 (b) \$142,000 each year is for equipment grants
12.2 to public educational radio stations. This
12.3 appropriation may be used for the repair,
12.4 rental, and purchase of equipment including
12.5 equipment under \$500.

12.6 (c) \$850,000 the first year is for grants to the
12.7 Association of Minnesota Public Educational
12.8 Radio Stations for the purchase of emergency
12.9 equipment and increased cybersecurity and
12.10 broadcast technology. The Association of
12.11 Minnesota Public Educational Radio Stations
12.12 may use up to four percent of this
12.13 appropriation for costs that are directly related
12.14 to and necessary for the administration of these
12.15 grants.

12.16 (d) \$1,288,000 the first year is for a grant to
12.17 the Association of Minnesota Public
12.18 Educational Radio Stations to provide a
12.19 diverse community radio news service. Of this
12.20 amount, up to \$38,000 is for the commissioner
12.21 of administration to administer this grant. This
12.22 is a onetime appropriation and is available
12.23 until June 30, 2027.

12.24 (e) \$1,020,000 each year is for equipment
12.25 grants to Minnesota Public Radio, Inc.,
12.26 including upgrades to Minnesota's Emergency
12.27 Alert and AMBER Alert Systems.

12.28 (f) The appropriations in paragraphs (a) to (e)
12.29 may not be used for indirect costs claimed by
12.30 an institution or governing body.

12.31 (g) The commissioner of administration must
12.32 consider the recommendations of the
12.33 Association of Minnesota Public Educational
12.34 Radio Stations before awarding grants under

13.1 Minnesota Statutes, section 129D.14, using
13.2 the appropriations in paragraphs (a) to (c). No
13.3 grantee is eligible for a grant unless they are
13.4 a member of the Association of Minnesota
13.5 Public Educational Radio Stations on or before
