1.8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.9	Section 1. Minnesota Statutes 2012, section 171.07, subdivision 1, is amended to read:
1.10	Subdivision 1. License; contents. (a) Upon the payment of the required fee, the
1.11	department shall issue to every qualifying applicant a license designating the type or
1.12	class of vehicles the applicant is authorized to drive as applied for. This license must
1.13	bear a distinguishing number assigned to the licensee; the licensee's full name and date
1.14	of birth; either (1) the licensee's residence address, or (2) the designated address under
1.15	section 5B.05; a description of the licensee in a manner as the commissioner deems
1.16	necessary; and the usual signature of the licensee. No license is valid unless it bears
1.17	the usual signature of the licensee. Every license must bear a colored photograph or an
1.18	electronically produced image of the licensee.
1.19	(b) If the United States Postal Service will not deliver mail to the applicant's
1.20	residence address as listed on the license, then the applicant shall provide verification from
1.21	the United States Postal Service that mail will not be delivered to the applicant's residence
1.22	address and that mail will be delivered to a specified alternate mailing address. When an
1.23	applicant provides an alternate mailing address under this subdivision, the commissioner
1.24	shall use the alternate mailing address in lieu of the applicant's residence address for
1.25	all notices and mailings to the applicant.

2.1 (c) Every license issued to an applicant under the age of 21 must be of a
2.2 distinguishing color and plainly marked "Under-21."

2.3 (d) The department shall use processes in issuing a license that prohibit, as nearly as
2.4 possible, the ability to alter or reproduce a license, or prohibit the ability to superimpose a
2.5 photograph or electronically produced image on a license, without ready detection.

2.6 (e) A license issued to an applicant age 65 or over must be plainly marked "senior" if
2.7 requested by the applicant.

2.8 Sec. 2. Minnesota Statutes 2012, section 171.07, subdivision 3, is amended to read:

Subd. 3. Identification card; fee. (a) Upon payment of the required fee, the 2.9 department shall issue to every qualifying applicant a Minnesota identification card. The 2.10 department may not issue a Minnesota identification card to an individual who has a 2.11 driver's license, other than a limited license. The department may not issue an enhanced 2.12 identification card to an individual who is under 16 years of age, not a resident of this state, 2.13 or not a citizen of the United States of America. The card must bear a distinguishing number 2.14 assigned to the applicant; a colored photograph or an electronically produced image of the 2.15 applicant; the applicant's full name and date of birth; either (1) the licensee's residence 2.16 address, or (2) the designated address under section 5B.05; a description of the applicant in 2.17 the manner as the commissioner deems necessary; and the usual signature of the applicant. 2.18

(b) If the United States Postal Service will not deliver mail to the applicant's
residence address as listed on the Minnesota identification card, then the applicant shall
provide verification from the United States Postal Service that mail will not be delivered
to the applicant's residence address and that mail will be delivered to a specified alternate
mailing address. When an applicant provides an alternate mailing address under this
subdivision, the commissioner shall use the alternate mailing address in lieu of the
applicant's residence address for all notices and mailings to the applicant.

2.26 (c) Each identification card issued to an applicant under the age of 21 must be of a
2.27 distinguishing color and plainly marked "Under-21."

2.28 (d) Each Minnesota identification card must be plainly marked "Minnesota
2.29 identification card - not a driver's license."

(e) The fee for a Minnesota identification card is 50 cents when issued to a person
who is developmentally disabled, as defined in section 252A.02, subdivision 2; a
physically disabled person, as defined in section 169.345, subdivision 2; or, a person with
mental illness, as described in section 245.462, subdivision 20, paragraph (c).

A person may notify the commissioner in writing to the effect that the person (1) is 3.24 the owner of a residence, and (2) does not consent to have that residence address identified 3.25 3.26 on any driver's license or identification card or driving record of the department as the residence address or permanent mailing address of any person named in the notice. The 3.27 notice may not name a spouse of the notifying person. Upon receiving the notice the 3.28 commissioner shall not issue any license or identification card under this chapter, or 3.29 accept an application for a license or identification card under this chapter, that lists the 3.30 residence address identified in the notice as the residence address or permanent mailing 3.31 address of any person named in the notice. 3.32
