1.6	Section 1. Minnesota Statutes 2018, section 174.01, subdivision 2, is amended to read:
1.7	Subd. 2. Transportation goals. The goals of the state transportation system are as
1.8	follows:
1.9	(1) to minimize fatalities and injuries for transportation users throughout the state;
1.10	(2) to provide multimodal and intermodal transportation facilities and services to increase
1.11	access for all persons and businesses and to ensure economic well-being and quality of life
1.12	without undue burden placed on any community;
1.13	(3) to provide a reasonable travel time for commuters;
1.14	(4) to enhance economic development and provide for the economical, efficient, and
1.15	safe movement of goods to and from markets by rail, highway, and waterway;
1.16	(5) to encourage tourism by providing appropriate transportation to Minnesota facilities
1.17	designed to attract tourists and to enhance the appeal, through transportation investments,
