1.6	Section 1. [135A.0432] AUTOMATIC ADMISSION.
1.7	Subdivision 1. Automatic admission. Each Minnesota public postsecondary institution
1.8	must admit an applicant to the institution as an undergraduate student in a baccalaureate
1.9	program if:
1.10	(1) the applicant graduated with a grade point average in the top ten percent of the
1.11	applicant's high school graduating class;
1.12	(2) the applicant graduated from high school in one of the two years preceding the
1.13	academic year for which the applicant is applying for admission;
1.14	(3) the applicant graduated from a public or private Minnesota high school; and
1.15	(4) the applicant was a resident of Minnesota for at least the past two years of the
