Minnesota Statutes 2018, section 363A.36, subdivision 1, is amended to read: 1.6 Subdivision 1. Scope of application. (a) For all contracts for goods and services in 17 excess of \$100,000, no department or agency of the state shall accept any bid or proposal 1.8 for a contract or agreement from any business having more than 40 full-time employees 1.9 within this state on a single working day during the previous 12 months, unless the 1.10 commissioner is in receipt of the business' affirmative action plan for the employment of 1.11 minority persons, women, and qualified disabled individuals. No department or agency of 1.12 the state shall execute any such contract or agreement until the affirmative action plan has 1.13 been approved by the commissioner. Receipt of a certificate of compliance issued by the 1.14 1.15 commissioner shall signify that a firm or business has an affirmative action plan that has been approved by the commissioner.
