ensure that grant awards are used by an eligible recipient only as reimbursement for eligible food or eligible educational activities.

Subd. 6. **Eligible uses.** (a) Except as provided in paragraph (b), a public school must use grant funds received under this section to purchase Minnesota grown unprocessed or minimally processed food, not including fluid milk, agricultural commodities, or yogurt containing artificial sweetener or more than eight ingredients.

(b) An eligible recipient may use up to 20 percent of grant funds received under this section to support educational activities that directly connect children and their families with agriculture and food including, but not limited to, school gardens, classroom-based gardening or cooking projects, tasting tables, field trips to farms, and chef visits or training.

Sec. 2. DEPARTMENT OF AGRICULTURE; APPROPRIATION.

\$4,500,000 in fiscal year 2018 and \$4,500,000 in fiscal year 2019 are appropriated from the general fund to the commissioner of agriculture for purposes of the farm-to-school administrative support, technical assistance, training, and grant program established in this act. The commissioner must award grants on a first-come, first-served basis and may give preference to eligible recipients with the highest percentage of free and reduced-price meal service. The commissioner must use up to \$100,000 of the appropriation each year to:

Sec. 3. UNIVERSITY OF MINNESOTA; APPROPRIATION.

\$300,000 in fiscal year 2018 and \$300,000 in fiscal year 2019 are appropriated from the general fund to the commissioner of agriculture for transfer to the Board of Regents of the University of Minnesota for three new agriculture extension positions, two of which must be based out of different, noncontiguous extension regions located outside of the Twin Cities metropolitan area. These extension positions must provide research-based education and technical assistance statewide to beginning, specialty crop, and small to midsize farmers and other farmers with demonstrated need in order to facilitate farm-to-school sales. This education and technical assistance includes, but is not limited to, education and outreach
