BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2010, section 120B.021, is amended to read:
1.8	120B.021 REQUIRED ACADEMIC STANDARDS.
1.9	Subdivision 1. Required academic standards. The following subject areas are
1.10	required for statewide accountability:
1.11	(1) language arts;
1.12	(2) mathematics;
1.13	(3) science;
1.14	(4) social studies, including history, geography, economics, and government and
1.15	citizenship;
1.16	(5) physical education;
1.17	(6) health, for which locally developed academic standards apply; and
1.18	(7) the arts, for which statewide or locally developed academic standards apply, as
1.19	determined by the school district. Public elementary and middle schools must offer at least
1.20	three and require at least two of the following four arts areas: dance; music; theater; and
1.21	visual arts. Public high schools must offer at least three and require at least one of the
1.22	following five arts areas: media arts; dance; music; theater; and visual arts-; and

Subd. 1a. Rigorous course of study; waiver. (a) Upon receiving a student's
application signed by the student's parent or guardian, a school district, area learning
center, or charter school must declare that a student meets or exceeds a specific academic
standard required for graduation under this section if the local school board, the school
board of the school district in which the area learning center is located, or the charter
school board of directors determines that the student:

(1) is participating in a course of study, including an advanced placement or
international baccalaureate course or program; a learning opportunity outside the
curriculum of the district, area learning center, or charter school; or an approved
preparatory program for employment or postsecondary education that is equally or more

rigorous than the corresponding state or local academic standard required by the district,
area learning center, or charter school;

- 3.31 (b) Academic standards must:
- 3.32 (1) be clear, concise, objective, measurable, and grade-level appropriate;

3.33 (2) not require a specific teaching methodology or curriculum; and

3.34 (3) be consistent with the Constitutions of the United States and the state of3.35 Minnesota.

4.1	Subd. 3. Rulemaking. The commissioner, consistent with the requirements of
4.2	this section and section 120B.022, must adopt statewide rules under section 14.389 for
4.3	implementing statewide rigorous core academic standards in language arts, mathematics,

4.5	this subdivision are initially adopted, the commissioner may not amend or repeal these

The Minnesota World Language Proficiency High Achievement Certificate
recognizes students who demonstrate listening, speaking, reading, and writing language
skills at the American Council on the Teaching of Foreign Languages' Pre-Advanced level
for K-12 learners on a valid and reliable assessment tool. For languages listed as Category
3 by the United States Foreign Service Institute or Category 4 by the United States
Defense Language Institute, the standard is Pre-Advanced for listening and speaking and
Intermediate-Mid for reading and writing.

5.11 EFFECTIVE DATE. This section is effective the day following final enactment
 5.12 and applies beginning with all 9th grade students in the 2012-2013 school year and later.

Sec. 3. Minnesota Statutes 2010, section 120B.023, subdivision 2, is amended to read: 5.13 Subd. 2. Revisions and reviews required. (a) The commissioner of education must 5.14 revise and appropriately embed technology and information literacy standards consistent 5.15 with recommendations from school media specialists into the state's academic standards 5.16 and graduation requirements and implement a review cycle for state academic standards 5.17 and related benchmarks, consistent with this subdivision. During each review cycle, the 5.18 commissioner also must examine the alignment of each required academic standard and 5.19 related benchmark with the knowledge and skills students need for college readiness and 5.20 advanced work in the particular subject area. 5.21

(b) The commissioner in the 2006-2007 school year must revise and align the state's
academic standards and high school graduation requirements in mathematics to require
that students satisfactorily complete the revised mathematics standards, beginning in the

 related benchmarks in arts beginning in the 2016-2017 school year.
- (d) The commissioner in the 2008-2009 school year must revise and align the state's
 academic standards and high school graduation requirements in science to require that
 students satisfactorily complete the revised science standards, beginning in the 2011-2012
 school year. Under the revised standards, students scheduled to graduate in the 2014-2015
 school year or later must satisfactorily complete a chemistry or physics credit. The
 commissioner must implement a review of the academic standards and related benchmarks
 in science beginning in the 2017-2018 school year.
- (e) The commissioner in the 2009-2010 school year must revise and align the state's
 academic standards and high school graduation requirements in language arts to require
 that students satisfactorily complete the revised language arts standards beginning in the
 2012-2013 school year. The commissioner must implement a review of the academic
 standards and related benchmarks in language arts beginning in the 2018-2019 school year.
- (f) The commissioner in the 2010-2011 school year must revise and align the state's
 academic standards and high school graduation requirements in social studies to require
 that students satisfactorily complete the revised social studies standards beginning in the
 2013-2014 school year. The commissioner must implement a review of the academic
 standards and related benchmarks in social studies beginning in the 2019-2020 school year.
- (g) The commissioner in the 2011-2012 school year must establish state world 6.23 languages academic standards, supplemented by related benchmarks, that require students 6.24 beginning 9th grade in the 2012-2013 school year and later, as a condition of graduating 6.25 from a public high school, to demonstrate an intermediate-low level of proficiency based 6.26 on the most current guidelines of the American Council on the Teaching of Foreign 6.27 Languages. Consistent with section 120B.022, subdivision 1, paragraph (b), governing 6.28 the language proficiency and cultural awareness of non-English language speakers, an 6.29 intermediate-low level of proficiency in a world language other than English that is 6.30 recognized by the American Council on the Teaching of Foreign Languages satisfies 6.31 the requirements of this paragraph. The commissioner must implement a review of 6.32 the academic standards and related benchmarks in world languages beginning in the 6.33 2017-2018 school year. 6.34
