1.7	Subdivision 1. Definitions. (a) For purposes of this subdivision, the following terms
1.8	have the meanings given.
1.9	(b) "Day of service" means a day that the qualifying employee missed work to serve in
1.10	the uniformed service in the taxable year while employed by the eligible employer.
1.11	(c) "Eligible employer" has the meaning given in section 45S(c)(1) of the Internal

1.13	(d) "Qualifying employee" means an employee who:
