1.7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.8	Section 1. Minnesota Statutes 2012, section 201.061, subdivision 1, is amended to read:
1.9	Subdivision 1. Prior to election day. (a) At any time except during the 20
1.10	days immediately preceding any regularly scheduled election, an eligible voter or any
1.11	individual who will be an eligible voter at the time of the next election may register to vote
1.12	in the precinct in which the voter maintains residence by completing a voter registration
1.13	application as described in section 201.071, subdivision 1, and submitting it. A completed
1.14	application may be submitted:
1.15	(1) in person or by mail to the county auditor of that county or to the Secretary
1.16	of State's Office <u>; or</u>
1.17	(2) electronically through a secure Web site that shall be maintained by the secretary
1.18	of state for this purpose, if the applicant has an e-mail address and provides the applicant's
1.19	verifiable Minnesota driver's license number, Minnesota state identification card number,
1.20	or the last four digits of the applicant's Social Security number.
1.21	A registration that is received in person or by mail no later than 5:00 p.m. on the

A voter registration 2.27 application must be of suitable size and weight for mailing and contain spaces for the 2.28 following required information: voter's first name, middle name, and last name; voter's 2.29 previous name, if any; voter's current address; voter's previous address, if any; voter's 2.30 date of birth; voter's municipality and county of residence; voter's telephone number, if 2.31 provided by the voter; date of registration; current and valid Minnesota driver's license 2.32 number or Minnesota state identification number, or if the voter has no current and valid 2.33 Minnesota driver's license or Minnesota state identification, the last four digits of the 2.34

voter's Social Security number; and voter's signature. The paper registration application 3.1 may include the voter's e-mail address, if provided by the voter, and. The electronic 3.2 voter registration application must include the voter's e-mail address. The registration 3.3 application may include the voter's interest in serving as an election judge, if indicated by 3.4 the voter. The application must also contain the following certification of voter eligibility: 3.5 "I certify that I: 3.6 (1) will be at least 18 years old on election day; 3.7 (2) am a citizen of the United States; 38 (3) will have resided in Minnesota for 20 days immediately preceding election day; 3.9 (4) maintain residence at the address given on the registration form; 3.10 (5) am not under court-ordered guardianship in which the court order revokes my 3.11 right to vote; 3.12 (6) have not been found by a court to be legally incompetent to vote; 3.13 (7) have the right to vote because, if I have been convicted of a felony, my felony 3.14 sentence has expired (been completed) or I have been discharged from my sentence; and 3.15 (8) have read and understand the following statement: that giving false information 3.16 is a felony punishable by not more than five years imprisonment or a fine of not more 3.17 than \$10,000, or both." 3.18 The certification must include boxes for the voter to respond to the following 3.19 questions: 3.20 "(1) Are you a citizen of the United States?" and 3.21 "(2) Will you be 18 years old on or before election day?" 3.22 And the instruction: 3.23 "If you checked 'no' to either of these questions, do not complete this form." 3.24 A paper voter registration application must be of suitable size and weight for 3 25 mailing. The form of the voter registration application and the certification of voter 3.26 eligibility must be as provided in this subdivision and approved by the secretary of state. 3.27 Voter registration forms authorized by the National Voter Registration Act must also be 3.28 accepted as valid. The federal postcard application form must also be accepted as valid if 3.29 it is not deficient and the voter is eligible to register in Minnesota. 3.30 An individual may use a voter registration application to apply to register to vote in 3.31 Minnesota or to change information on an existing registration. 3.32 Sec. 4. 3.34 Subd. 3. **Deficient registration.** No voter registration application is deficient if it 3.35 contains the voter's name, address, date of birth, current and valid Minnesota driver's

license number or Minnesota state identification number, or if the voter has no current and 4.1 valid Minnesota driver's license or Minnesota state identification number, the last four 4.2 digits of the voter's Social Security number, if the voter has been issued a Social Security 4.3 number, prior registration, if any, and signature. The absence of a zip code number does 4.4 not cause the registration to be deficient. Failure to check a box on an application form 4.5 that a voter has certified to be true does not cause the registration to be deficient. The 4.6 election judges shall request an individual to correct a voter registration application if it is 4.7 deficient or illegible. No eligible voter may be prevented from voting unless the voter's 48 registration application is deficient or the voter is duly and successfully challenged in 4.9 accordance with section 201.195 or 204C.12. 4.10

A voter registration application accepted prior to August 1, 1983, is not deficient
for lack of date of birth. The county or municipality may attempt to obtain the date of
birth for a voter registration application accepted prior to August 1, 1983, by a request to
the voter at any time except at the polling place. Failure by the voter to comply with this
request does not make the registration deficient.

A voter registration application accepted before January 1, 2004, is not deficient for
lack of a valid Minnesota driver's license or state identification number or the last four
digits of a Social Security number. A voter registration application submitted by a voter
who does not have a Minnesota driver's license or state identification number, or a Social
Security number, is not deficient for lack of any of these numbers.

201.275 INVESTIGATIONS; PROSECUTIONS.

A law enforcement agency that is notified by affidavit of an alleged violation of this 5.12 chapter shall promptly investigate. Upon receiving an affidavit alleging a violation of this 5.13 chapter, a county attorney shall promptly forward it to a law enforcement agency with 5.14 jurisdiction for investigation. If there is probable cause for instituting a prosecution, 5.15 the county attorney shall proceed by complaint or present the charge, with whatever 5.16 evidence has been found, to the grand jury. A county attorney who refuses or intentionally 5.17 fails to faithfully perform this or any other duty imposed by this chapter is guilty of 5.18 a misdemeanor and upon conviction shall forfeit office.
