1.7	Section 1. Minnesota Statutes 2022, section 120A.42, is amended to read:
1.8	120A.42 CONDUCT OF SCHOOL ON CERTAIN HOLIDAYS.
1.9	(a) The governing body of any district may contract with any of the teachers of the
1.10	district for the conduct of schools, and may conduct schools, on either, or any, of the
1.11	following holidays, provided that a clause to this effect is inserted in the teacher's contract:
1.12	Martin Luther King's birthday, Lincoln's and Washington's birthdays, Columbus Day
1.13	Indigenous Peoples' Day, and Veterans' Day. On Martin Luther King's birthday, Washington's
1.14	birthday, Lincoln's birthday, and Veterans' Day at least one hour of the school program
1.15	must be devoted to a patriotic observance of the day. On Indigenous Peoples' Day, at least
1.16	one hour of the school program must be devoted to observance of the day. As part of its
1.17	observance of Indigenous Peoples' Day, a district may provide professional development

be a holiday. No public business shall be transacted on any holiday, except in cases of
necessity and except in cases of public business transacted by the legislature, nor shall any
civil process be served thereon. However, for the executive branch of the state of Minnesota,
"holiday" also includes the Friday after Thanksgiving but does not include Christopher

2.27 Columbus Day. Other branches of state government and political subdivisions shall have
2.28 the option of determining whether Christopher Columbus Day and the Friday after
2.29 Thanksgiving shall be holidays a holiday. Where it is determined that Columbus Day or the
2.30 Friday after Thanksgiving is not a holiday, public business may be conducted thereon.

Any agreement between a public employer and an employee organization citing Veterans
Day as the fourth Monday in October shall be amended to cite Veterans Day as November
11.
