1.5	Section 1. Minnesota Statutes 2020, section 169.09, subdivision 13, is amended to read:
1.6	Subd. 13. Reports confidential; evidence, fee, penalty, appropriation. (a) All reports
1.7	and supplemental information required under this section must be for the use of the
1.8	commissioner of public safety and other appropriate state, federal, county, and municipal
1.9	governmental agencies for accident analysis purposes, except:
1.10	(1) upon written request, the commissioner of public safety or any law enforcement
1.11	agency shall disclose the report required under subdivision 8 to:
1.12	(i) any individual involved in the accident, the representative of the individual's estate,

 - (e) The commissioner of public safety shall charge authorized persons as described in
 paragraph (a) a \$5 fee for a copy of an accident report. Ninety percent of the \$5 fee collected
 under this paragraph must be deposited in the special revenue fund and credited to the driver

3.2 in the general fund. The commissioner may also furnish an electronic copy of the database
3.3 of accident records, which must not contain personal or private data on an individual, to
3.4 private agencies as provided in paragraph (g), for not less than the cost of preparing the

(f) The fees specified in paragraph (e) notwithstanding, the commissioner and law 3.6 enforcement agencies shall charge commercial users who request access to response or 3.7 incident data relating to accidents a fee not to exceed 50 cents per record. "Commercial 3.8 user" is a user who in one location requests access to data in more than five accident reports 3.9 per month, unless the user establishes that access is not for a commercial purpose. Of the 3.10 money collected by the commissioner under this paragraph, 90 percent must be deposited 3.11 in the special revenue fund and credited to the driver services operating account established 3.12 in section 299A.705 and ten percent must be deposited in the general fund. 3.13

(g) The fees in paragraphs (e) and (f) notwithstanding, the commissioner shall provide
an electronic copy of the accident records database to the public on a case-by-case basis
using the cost-recovery charges provided for under section 13.03, subdivision 3. The database
provided must not contain personal or private data on an individual. However, unless the
accident records database includes the vehicle identification number, the commissioner
shall include the vehicle registration plate number if a private agency certifies and agrees
that the agency:

3.21 (1) is in the business of collecting accident and damage information on vehicles;

3.22 (2) will use the vehicle registration plate number only for identifying vehicles that have
3.23 been involved in accidents or damaged, to provide this information to persons seeking access
3.24 to a vehicle's history and not for identifying individuals or for any other purpose; and

3.25 (3) will be subject to the penalties and remedies under sections 13.08 and 13.09.
