2.18 Fish taken by a nonresident under age 16 without a license must be included in the limit of  
2.19 the parent or guardian;

2.20 (2) purchase a youth fishing license under section 97A.475, subdivision 7, paragraph

2.21 (a), clause (8), and possess a limit of fish; or

2.22 (3) be included under a nonresident family angling license and possess a limit of fish.

2.23 (b) A nonresident age 16 or over and under age 18 must purchase a youth license to  
2.24 angle under section 97A.475, subdivision 7, paragraph (a), clause (8).

2.25 (c) Nonresidents age 16 or over and under age 18 may take fish by spearing without a  
2.26 spearing license but must possess a fishing license under section 97A.475, subdivision 7,  
2.27 paragraph (a), clause (8).

2.28 (d) Nonresidents under age 16 may take fish by spearing without a spearing or angling  
2.29 license.

(e) Limits for fish taken by spearing must comply with one of the options listed under paragraph (a).

(f) Nonresidents age 16 or over and under age 18 may take muskellunge without a muskellunge license but must possess an angling license under section 97A.475, subdivision 7, paragraph (a), clause (8). Nonresidents under age 16 may take muskellunge without a muskellunge or angling license.

Sec. 5. Minnesota Statutes 2018, section 97A.475, subdivision 6, is amended to read:

Subd. 6. **Resident fishing.** Fees for the following licenses, to be issued to residents only, are:

(1) for persons age 18 or over to take fish by angling, \$25;

(2) for persons age 18 or over to take fish by angling, for a combined license for a married couple, \$40;

(3) for persons age 18 or over to take fish by spearing from a dark house, \$6, and the person must possess an angling license;

(4) for persons age 18 or over to take fish by angling for a 24-hour period selected by the licensee, \$12;

(5) for persons age 18 or over to take fish by angling for a consecutive 72-hour period selected by the licensee, \$14;

(6) for persons age 18 or over to take fish by angling for three consecutive years, \$71; ~~and~~

(7) for persons age 16 or over and under age 18 to take fish by angling, \$5; and

(8) for persons age 18 or over to take muskellunge, \$10, and the person must possess an angling license.

Subd. 7. **Nonresident fishing.** (a) Fees for the following licenses, to be issued to nonresidents, are:

(1) for persons age 18 or over to take fish by angling, \$46;

(2) for persons age 18 or over to take fish by angling limited to seven consecutive days selected by the licensee, \$38;

4.18 Subd. 6. **Licenses to be sold and issuing fees.** (a) Persons authorized to sell licenses  
4.19 under this section must issue the following licenses for the license fee and the following  
4.20 issuing fees:

4.21 (1) to take deer or bear with firearms and by archery, the issuing fee is \$1;

4.22 (2) Minnesota sporting, the issuing fee is \$1;

4.23 (3) to take small game, to take fish by angling or by spearing, to take muskellunge, and  
4.24 to trap fur-bearing animals, the issuing fee is \$1;

4.25 (4) to apply for a limited hunt drawing, the issuing fee is \$1 unless the application requires  
4.26 a license purchase at the time of application and the license purchase requires an application  
4.27 fee;

4.28 (5) for a prairie-chicken license, the issuing fee is \$1;

4.29 (6) for a turkey license, the issuing fee is \$1;

- 5.5 (11) for stamp validations issued simultaneously with a license, there is no fee;
- 5.6 (12) for licenses, seals, tags, or coupons issued without a fee under section 97A.441,  
5.7 subdivisions 1 to 6a, or 97A.465, there is no fee;
- 5.8 (13) for lifetime licenses, there is no fee; and
- 5.9 (14) for all other licenses, permits, renewals, or applications or any other transaction  
5.10 through the electronic licensing system under this chapter or any other chapter when an  
5.11 issuing fee is not specified, an issuing fee of \$1 may be charged at the discretion of the  
5.12 authorized seller.
- 5.13 (b) Only one issuing fee may be collected when selling more than one stamp in the same  
5.14 transaction after the end of the season for which the stamp was issued.
- 5.15 (c) The agent shall keep the issuing fee as a commission for selling the licenses.
- 5.16 (d) The commissioner shall collect the issuing fee on licenses sold by the commissioner.
- 5.17 (e) A license, except stamps, must state the amount of the issuing fee and that the issuing  
5.18 fee is kept by the seller as a commission for selling the licenses.
- 5.19 (f) For duplicate licenses, including licenses issued without a fee, the issuing fees are:
- 5.20 (1) for licenses to take big game, 75 cents; and
- 5.21 (2) for other licenses, 50 cents.
- 5.22 (g) The commissioner may issue one-day angling licenses in books of ten licenses each  
5.23 to fishing guides operating charter boats upon receipt of payment of all license fees, excluding  
5.24 the issuing fee required under this section. Copies of sold and unsold licenses shall be  
5.25 returned to the commissioner. The commissioner shall refund the charter boat captain for  
5.26 the license fees of all unsold licenses. Copies of sold licenses shall be maintained by the  
5.27 commissioner for one year.
