1.5	Section 1. [604A.40] AGRITOURISM; IMMUNITY FROM LIABILITY.
1.6	Subdivision 1. <b>Definitions.</b> (a) For the purposes of this section, the terms in
1.7	paragraphs (b) to (g) have the meanings given them.
1.8	(b) "Agricultural products" means livestock, aquaculture, poultry, horticultural,
1.9	floricultural, viticultural, silvicultural, or other products of a farm or ranch.
1.10	(c) "Agritourism activity" means activity carried out on a farm or ranch that allows
1.11	organizations or members of the general public, for recreational, entertainment, charitable,

2.7	agritourism professional is not liable for injury, damage, or death of a participant resulting
