1.6	Section 1. Minnesota Statutes 2014, section 16A.1283, is amended to read:

1.7	16A.1283 LEGISLATIVE APPROVAL REQUIRED FOR FEES.
1.8	(a) Notwithstanding any law to the contrary, an executive branch state agency may
1.9	not impose a new fee or increase an existing fee unless the new fee or increase is approved
1.10	by law. An agency must not propose a fee or fine increase of more than ten percent
1.11	in a biennium over the same fee or fine in law at the start of the same biennium. For
1.12	purposes of this section, a fee is any charge for goods, services, regulation, or licensure,
1.13	and, notwithstanding paragraph (b), clause (3), includes charges for admission to or for
1.14	use of public facilities owned by the state.
1.15	(b) This section does not apply to:
1.16	(1) charges billed within or between state agencies, or billed to federal agencies;
1.17	(2) the Minnesota State Colleges and Universities system;
1.18	(3) charges for goods and services provided for the direct and primary use of a
1.19	private individual, business, or other entity;
1.20	(4) charges that authorize use of state-owned lands and minerals administered by
1.21	the commissioner of natural resources by the issuance of leases, easements, cooperative
1.22	farming agreements, and land and water crossing licenses and charges for sales of
1.23	state-owned lands administered by the commissioner of natural resources; or

## Sec. 2. STATE AUDITOR REPORT.
