1.8	Subdivision 1. Eligibility. All nonexempt property which, in a given taxes payable year,
1.9	is subject to a levy certified by a school district under section 275.07 is eligible to receive
1.10	the credit under this section.
1.11	Subd. 2. Credit amount. For property taxes payable in 2024 and 2025, the credit under
1.12	this section is equal to 100 percent of the property tax that is payable to a school district in
1.13	the respective taxes payable year, after any other applicable credits. For property taxes
1.14	payable in 2026 and thereafter, the credit under this section is equal to \$0.
1.15	Subd. 3. Credit determination. The county auditor must determine the tax reductions

(a) The county auditor shall prepare and 3.8 the county treasurer shall deliver after November 10 and on or before November 24 each 3.9 year, by first class mail to each taxpayer at the address listed on the county's current year's 3.10 assessment roll, a notice of proposed property taxes. Upon written request by the taxpayer, 3.11 the treasurer may send the notice in electronic form or by electronic mail instead of on paper 3.12
- 3.13 or by ordinary mail.

3.14 (b) The commissioner of revenue shall prescribe the form of the notice.

(c) The notice must inform taxpayers that it contains the amount of property taxes each 3.15 taxing authority proposes to collect for taxes payable the following year. In the case of a 3.16 town, or in the case of the state general tax, the final tax amount will be its proposed tax. 3.17 The notice must clearly state for each city that has a population over 500, county, school 3.18 district, regional library authority established under section 134.201, metropolitan taxing 3.19 districts as defined in paragraph (i), and fire protection and emergency medical services 3.20 special taxing districts established under section 144F.01, the time and place of a meeting 3.21 for each taxing authority in which the budget and levy will be discussed and public input 3.22 allowed, prior to the final budget and levy determination. The taxing authorities must provide 3.23 the county auditor with the information to be included in the notice on or before the time it 3.24 certifies its proposed levy under subdivision 1. The public must be allowed to speak at that 3.25 meeting, which must occur after November 24 and must not be held before 6:00 p.m. It 3.26 must provide a telephone number for the taxing authority that taxpayers may call if they 3.27 have questions related to the notice and an address where comments will be received by 3.28 3.29 mail, except that no notice required under this section shall be interpreted as requiring the printing of a personal telephone number or address as the contact information for a taxing 3.30 authority. 4.2 (1) the market value of the property as determined under section 273.11, and used for

4.6 or nonhomestead. The notice must clearly inform taxpayers of the years to which the market
4.7 values apply and that the values are final values;

4.8 (2) the items listed below, shown separately by county, city or town, and state general
4.9 tax, agricultural homestead credit under section 273.1384, school building bond agricultural
4.10 credit under section 273.1387, school levy credit under section 273.1389, voter approved

In the case of a town or the state general tax, the final tax shall also be its proposed tax 4.18 unless the town changes its levy at a special town meeting under section 365.52. If a school 4.19 district has certified under section 126C.17, subdivision 9, that a referendum will be held 4.20 in the school district at the November general election, the county auditor must note next 4.21 to the school district's proposed amount that a referendum is pending and that, if approved 4.22 by the voters, the tax amount may be higher than shown on the notice. In the case of the 4.23 city of Minneapolis, the levy for Minneapolis Park and Recreation shall be listed separately 4.24 from the remaining amount of the city's levy. In the case of the city of St. Paul, the levy for 4.25 the St. Paul Library Agency must be listed separately from the remaining amount of the 4.26 city's levy. In the case of Ramsey County, any amount levied under section 134.07 may be 4.27 listed separately from the remaining amount of the county's levy. In the case of a parcel 4.28 where tax increment or the fiscal disparities areawide tax under chapter 276A or 473F 4.29 applies, the proposed tax levy on the captured value or the proposed tax levy on the tax 4.30 capacity subject to the areawide tax must each be stated separately and not included in the 4.31 sum of the special taxing districts; and 4.32

4.33 (3) the increase or decrease between the total taxes payable in the current year and the4.34 total proposed taxes, expressed as a percentage.

It may include only information regarding: 6.19 (1) the impact of inflation as measured by the implicit price deflator for state and local 6.20 government purchases; 6.21 (2) population growth and decline; 6.22 (3) state or federal government action; and 6.23 6.24 (4) other financial factors that affect the level of property taxation and local services that the governing body of the county, city, or school district may deem appropriate to 6.25 include. 6.26
- 6.27 The information may be presented using tables, written narrative, and graphic
 6.28 representations and may contain instruction toward further sources of information or
 6.29 opportunity for comment.

Sec. 5. Minnesota Statutes 2022, section 276.04, subdivision 2, is amended to read:

Subd. 2. Contents of tax statements. (a) The treasurer shall provide for the printing of 7.2 the tax statements. The commissioner of revenue shall prescribe the form of the property 7.3 tax statement and its contents. The tax statement must not state or imply that property tax 7.4 credits are paid by the state of Minnesota. The statement must contain a tabulated statement 7.5 of the dollar amount due to each taxing authority and the amount of the state tax from the 7.6 parcel of real property for which a particular tax statement is prepared. The dollar amounts 7.7 attributable to the county, the state tax, the voter approved school tax, the other local school 7.8 tax, the township or municipality, and the total of the metropolitan special taxing districts 7.9 as defined in section 275.065, subdivision 3, paragraph (i), must be separately stated. The 7.10 amounts due all other special taxing districts, if any, may be aggregated except that any 7.11 levies made by the regional rail authorities in the county of Anoka, Carver, Dakota, Hennepin, 7.12 Ramsey, Scott, or Washington under chapter 398A shall be listed on a separate line directly 7.13 under the appropriate county's levy. If the county levy under this paragraph includes an 7.14 amount for a lake improvement district as defined under sections 103B.501 to 103B.581, 7.15 the amount attributable for that purpose must be separately stated from the remaining county 7.16 levy amount. In the case of Ramsey County, if the county levy under this paragraph includes 7.17 an amount for public library service under section 134.07, the amount attributable for that 7.18 purpose may be separated from the remaining county levy amount. The amount of the tax 7.19 on homesteads qualifying under the senior citizens' property tax deferral program under 7.20 chapter 290B is the total amount of property tax before subtraction of the deferred property 7.21 tax amount. The amount of the tax on contamination value imposed under sections 270.91 7.22 to 270.98, if any, must also be separately stated. The dollar amounts, including the dollar 7.23 amount of any special assessments, may be rounded to the nearest even whole dollar. For 7.24 purposes of this section whole odd-numbered dollars may be adjusted to the next higher 7.25 even-numbered dollar. The amount of market value excluded under section 273.11, 7.26 subdivision 16, if any, must also be listed on the tax statement. 7.27

(b) The property tax statements for manufactured homes and sectional structures taxed
as personal property shall contain the same information that is required on the tax statements
for real property.

(c) Real and personal property tax statements must contain the following information
in the order given in this paragraph. The information must contain the current year tax
information in the right column with the corresponding information for the previous year
in a column on the left:
