1.7	Section 1. [216C.331] ENERGY BENCHMARKING.
1.8	Subdivision 1. Definitions. (a) For the purposes of this section, the following terms have
1.9	the meanings given.
1.10	(b) "Aggregated customer energy use data" means customer energy use data, which is
1.11	combined into one collective data point per time interval. Aggregated customer energy use
1.12	data is data with any unique identifiers or other personal information removed that a
1.13	qualifying utility collects and aggregates in at least monthly intervals for an entire covered
1.14	building.
1.15	(c) "Benchmark" means to electronically input into a benchmarking tool the total energy
1.16	use data and other descriptive information about a building that is required by a benchmarking
1.17	tool.
1.18	(d) "Benchmarking information" means data related to a building's energy use generated
1.19	by a benchmarking tool, and other information about the building's physical and operational
1.20	characteristics. Benchmarking information includes but is not limited to the building's:

2.11	that reflect the quantity, quality, or timing of customers' usage.

2.27	(k) "Energy Star Portfolio Manager" means an interactive resource management tool
2.28	developed by the United States Environmental Protection Agency that (1) enables the
2.29	periodic entry of a building's energy use data and other descriptive information about a
2.30	building, and (2) rates a building's energy efficiency against that of comparable buildings
2.31	nationwide.

8.22	ordinance or resolution that imposes more stringent benchmarking requirements. For purposes

9.11	provide disclosure materials for public display within a building to building owners, such
9.12	that building owners can prominently display the performance of the building. The materials
9.13	must include the number of stars assigned to the building by the commissioner under
9.14	subdivision 9, paragraph (c), and relevant explanation of rating.
9.15	Subd. 13. Notifications. By March 1 each year, the commissioner must notify the owner
9.16	of each covered property required to benchmark for the previous calendar year of the
9.17	requirement to benchmark by June 1 of that year.
9.18	Subd. 14. Program implementation. The commissioner may contract with an
9.19	independent third party to implement any or all of the commissioner's duties required under
9.20	this section. To implement the benchmarking program, the commissioner shall assist building
9.21	owners to increase energy efficiency and reduce greenhouse gas emissions from their
9.22	buildings, including by providing outreach, training, and technical assistance to building
9.23	owners to help their buildings come into compliance with the benchmarking program.
9.24	Subd. 15. Enforcement. By June 15 each year, the commissioner must notify the owner
9.25	of each covered property required to comply with this section that has failed to comply that
9.26	the owner has until July 15 to come into compliance, unless the owner requests an extension,
9.27	in which case the owner has until August 15 to come into compliance. If an owner fails to
9.28	comply with the requirements of this section by July 15 and fails to request an extension
9.29	by that date, or is given an extension and fails to comply by August 15, the commissioner
9.30	may impose a civil fine of \$1,000 on the owner. The commissioner may by rule increase
9.31	the civil fine to adjust for inflation.

10.2	(a) \$1,000,000 in fiscal year 2024 and \$1,000,000 in fiscal year 2025 are appropriated

10.5	(b) \$750,000 in fiscal year 2024 is appropriated from the general fund to the commissioner
10.6	of commerce to award grants to qualifying utilities that are not investor-owned utilities to
10.7	support the development of technology for implementing Minnesota Statutes, section
10.8	216C.331. Any balance does not cancel but is available until June 30, 2026.
10.9	(c) \$750,000 in fiscal year 2023 is appropriated from the general fund to the commissioner
