1.5	WHEREAS, the Perkins Loan Program is the nation's longest running federal student loan
1.6	program created in 1958 as the National Defense Student Loan Program and later called the National
1.7	Direct Loan Program; and
1.8	WHEREAS, Perkins Loans are efficient, need-based, low-interest loans that serve over 11,000
1.9	high-need, low-income college students at over 40 colleges and universities in Minnesota and
1.10	500,000 students at some 1,500 colleges and universities in the United States each year; and
1.11	WHEREAS, Perkins Loans have favorable terms for students; for example, interest is not
1.12	charged while students are in school, the interest rate is low and fixed, and borrowers may have all
1.13	or part of their Perkins Loans canceled if they undertake certain public service jobs for one to five
1.14	years; and
1.15	WHEREAS, participating schools share the risk of the Perkins Loan Program because they
1.16	provide a one-third match to federal capital contributions, and loans are made using funds repaid
1.17	by previous borrowers; and
1.18	WHEREAS, Perkins Loans feature the human touch of campus-based servicing, which allows
1.19	on-campus administrators to provide Perkins borrowers with one-on-one service; and
1.20	WHEREAS, Perkins Loans have made higher education possible for millions of Americans;

1.22	WHEREAS, the Perkins Loan Program fosters access to postsecondary education for
1.23	low-income students during a period of declining grant availability; and

2.1	WHEREAS, without Perkins Loans, thousands of Americans will lose the chance at higher

2.3	WHEREAS, there is no replacement for Perkins Loans; NOW, THEREFORE,

2.5	and the Congress of the United States to continue the Perkins Loan Program, in its entirety and
2.6	original form, in order to provide educational opportunities to future generations of students who
2.7	need low-cost financing to make their dreams of higher education possible.
