(a) For all contracts for goods and services in excess of \$100,000, neither the 3.5 council nor an agency listed in section 473.143, subdivision 1, shall accept any bid or 3.6 proposal for a contract or agreement from any business having more than 40 full-time 3.7 employees within this state on a single working day during the previous 12 months, or a 3.8 state where the business has its primary place of business on a single working day during 3.9 the previous 12 months, unless the firm or business has an affirmative action plan for the 3.10 employment of minority persons, women, and qualified disabled individuals submitted 3.11 to the commissioner of human rights for approval.
