1.9	Subd. 9. Fantasy sports contests. Fantasy sports contests as defined and conducted			
1.10	under chapter 325O are exempt from taxation under this section.

1.12	Subdivision 1. Scope. As used in this chapter, the terms in this section have the

541.20 RECOVERY OF MONEY LOST.

Every person who, by playing at cards, dice, or other game, or by betting on the 3.26 hands or sides of such as are gambling, shall lose to any person so playing or betting 3.27 any sum of money or any goods, and pays or delivers the same, or any part thereof, to 3.28 the winner, may sue for and recover such money by a civil action, before any court 3.29 of competent jurisdiction. For purposes of this section, gambling shall not include 3.30 pari-mutuel wagering conducted under a license issued pursuant to chapter 240, purchase 3.31 or sale of tickets in the state lottery, or gambling authorized under chapters 349 and 349A, 3.32 or participation in fantasy sports contests under chapter 325O. 3.33
