1.6	Section 1. CAPITOL CAMPUS DESIGN FRAMEWORK; APPROPRIATIONS.
1.7	Subdivision 1. Design framework updates; appropriation. (a) \$1,000,000 in fiscal
1.8	year 2023 is appropriated from the general fund to the Capitol Area Architectural and
1.9	Planning Board to update the Capitol Mall Design Framework and for initial implementation
1.10	of the framework. This is a onetime appropriation and is available until December 31, 2024.
1.11	The updated design framework must include:
1.12	(1) plans to integrate green space campus-wide, including but not limited to the addition
1.13	of green space on the following sites at the approximate sizes indicated:
1.14	(i) the southwest corner of Rice Street and University Avenue, with a minimum size of
1.15	<u>20,700 square feet;</u>
1.16	(ii) the northeast corner of Rice Street and University Avenue, with a minimum size of

2.6	(b) The board must contract with one or more professional design consultants with
2.7	expertise on horticulture, landscape architecture, civic space design, infrastructure assessment,
