1.7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.8	Section 1. [41A.107] RENEWABLE CHEMICAL AND ADVANCED BIOFUEL
1.9	CAPITAL EQUIPMENT LOANS.
1.10	(a) There is established a renewable chemical and advanced biofuel revolving loan
1.11	fund that is eligible to receive appropriations and make loans under this section. The
1.12	commissioner shall establish a renewable chemical and advanced biofuel loan program
1.13	to make loans for capital equipment to persons participating in advanced biofuel and
1.14	renewable chemical production facilities. The commissioner, in consultation with the
1.15	board established in section 41A.105, subdivision 2, shall establish guidelines for loans
1.16	made under this section. All repayments of loans granted from this fund, including
1.17	principal and interest, must be deposited into this fund. Interest earned on money in the
1.18	fund accrues to the fund, and the money in the fund is appropriated to the commissioner to
1.19	make renewable chemical and advanced biofuel capital equipment loans under this section.
1.20	(b) The definitions in sections 41A.13, subdivision 2, and 41A.14, subdivision
