The application must include: 2.2 (1) a description of the proposed program, including the number of hours per week the 23 program will be offered at each school site or mixed-delivery location; 2.4 2.5 (2) an estimate of the number of eligible children to be served in the program at each school site or mixed-delivery location; and 2.6 2.7 (3) a statement of assurances signed by the superintendent or charter school director that the proposed program meets the requirements of subdivision 2. 2.8 (b) The commissioner must review all applications submitted for fiscal year 2017 by 2.9 August 1, 2016, and must review all applications submitted for fiscal year 2018 and later 2.10 by March 1 of the fiscal year in which the applications are received and determine whether 2.11 each application meets the requirements of paragraph (a). 2.12

(d) If the participation limit under subdivision 6 is higher than the participation limit for 3.7 the previous year, the limit on participation for the programs as specified in subdivision 6 3.8 must initially be allocated among the four five groups based on each group's percentage 3.9 3.10 share of the statewide kindergarten enrollment on October 1 of the previous school year. If the participation limit is the same as the participation limit for the previous year, the 3.11 participation limit must initially be allocated among the five groups based on each group's 3.12 participation limit for the previous school year. Within each group, the participation limit 3.13 for fiscal years 2018 and 2019 must first be allocated to school sites approved for aid in the 3.14 previous year to ensure that those sites are funded for the same number of participants as 3.15 approved for the previous year. The remainder of the participation limit for each group must 3.16 be allocated among school sites in priority order until that region's share of the participation 3.17 limit is reached. If the participation limit is not reached for all groups, the remaining amount 3.18 must be allocated to the highest priority school sites, as designated under this section, not 3.19 funded in the initial allocation on a statewide basis.
