1.9	state, no government entity or its subdivisions, agents, or assigns are permitted to issue
1.10	vaccine passports, vaccine passes, or any other standardized documentation for the purpose
1.11	of certifying an individual's COVID-19 vaccination status or post-transmission recovery to
1.12	a third party or otherwise publish or share an individual's COVID-19 vaccination record or

1.14	(b) For purposes of this section, "vaccine passport" or "vaccine pass" means proof that
