1.24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.25 Section 1. Minnesota Statutes 2024, section 3.922, subdivision 1, is amended to read:

1.26 Subdivision 1. **Creation, membership.** The state Indian Affairs Council is created to  
1.27 consist of the following members:

1.28 (1) one member of each of the following federally recognized tribes, designated by the  
1.29 elected tribal president or chairperson of the governing bodies of:

1.30 the Fond du Lac Band;

- 2.1 the Grand Portage Band;
- 2.2 the Mille Lacs Band;
- 2.3 the White Earth Band;
- 2.4 the Bois Forte (Nett Lake) Band;
- 2.5 the Leech Lake Band;
- 2.6 the Red Lake Nation;
- 2.7 the Upper Sioux Community;
- 2.8 the Lower Sioux Community;
- 2.9 the Shakopee Mdewakanton Sioux Community;
- 2.10 the Prairie Island Mdewakanton Dakota Community;
- 2.11 (2) a member of the governor's official staff designated by the governor;
- 2.12 the commissioner of education;
- 2.13 the commissioner of human services;
- 2.14 the commissioner of natural resources;
- 2.15 the commissioner of human rights;
- 2.16 the commissioner of employment and economic development;
- 2.17 the commissioner of corrections;
- 2.18 the commissioner of the Minnesota Housing Finance Agency;
- 2.19 the commissioner of Iron Range resources and rehabilitation;
- 2.20 the commissioner of health;
- 2.21 the commissioner of transportation;

3.2 Members appointed to represent the house of representatives or the senate shall no longer  
3.3 serve on the council when they are no longer members of the bodies which they represent  
3.4 and their offices shall be vacant. A member who is a designee of a tribal president or  
3.5 chairperson shall cease to be a member at the end of the term of the designating tribal  
3.6 president or chairperson. Only members of the council designated under clause (1) shall  
3.7 vote.

3.8 Sec. 2. Minnesota Statutes 2024, section 13.41, subdivision 1, is amended to read:

3.9 Subdivision 1. **Definition.** As used in this section "licensing agency" means any board,  
3.10 department or agency of this state which is given the statutory authority to issue professional  
3.11 or other types of licenses, except the various agencies primarily administered by the  
3.12 commissioner of human services or the commissioner of children, youth, and families. Data  
3.13 pertaining to persons or agencies licensed or registered under authority of the commissioner  
3.14 of human services or the commissioner of children, youth, and families shall be administered  
3.15 pursuant to section 13.46.

3.16 Sec. 3. Minnesota Statutes 2024, section 13.46, subdivision 3, is amended to read:

3.17 Subd. 3. **Investigative data.** (a) Data on persons, including data on vendors of services,  
3.18 licensees, and applicants that is collected, maintained, used, or disseminated by the welfare  
3.19 system in an investigation, authorized by statute, and relating to the enforcement of rules  
3.20 or law are confidential data on individuals pursuant to section 13.02, subdivision 3, or  
3.21 protected nonpublic data not on individuals pursuant to section 13.02, subdivision 13, and  
3.22 shall not be disclosed except:

3.23 (1) pursuant to section 13.05;

3.24 (2) pursuant to statute or valid court order;

3.25 (3) to a party named in a civil or criminal proceeding, administrative or judicial, for  
3.26 preparation of defense;

3.27 (4) to an agent of the welfare system or an investigator acting on behalf of a county,  
3.28 state, or federal government, including a law enforcement officer or attorney in the  
3.29 investigation or prosecution of a criminal, civil, or administrative proceeding, unless the  
3.30 commissioner of human services or the commissioner of children, youth, and families  
3.31 determines that disclosure may compromise a Department of Human Services or Department  
3.32 of Children, Youth, and Families ongoing investigation; or

4.1 (5) to provide notices required or permitted by statute.

4.2 The data referred to in this subdivision shall be classified as public data upon submission  
4.3 to an administrative law judge or court in an administrative or judicial proceeding. Inactive  
4.4 welfare investigative data shall be treated as provided in section 13.39, subdivision 3.

4.5 (b) Notwithstanding any other provision in law, the commissioner of human services or  
4.6 the commissioner of children, youth, and families shall provide all active and inactive  
4.7 investigative data, including the name of the reporter of alleged maltreatment under section  
4.8 626.557 or chapter 260E, to the ombudsman for mental health and developmental disabilities  
4.9 upon the request of the ombudsman.

4.10 (c) Notwithstanding paragraph (a) and section 13.39, the existence of an investigation  
4.11 by the commissioner of human services or the commissioner of children, youth, and families  
4.12 of possible overpayments of public funds to a service provider or recipient may be disclosed  
4.13 if the commissioner determines that it will not compromise the investigation.

4.14 Sec. 4. Minnesota Statutes 2024, section 13.46, subdivision 4, is amended to read:

4.15 Subd. 4. **Licensing data.** (a) As used in this subdivision:

4.16 (1) "licensing data" are all data collected, maintained, used, or disseminated by the  
4.17 welfare system pertaining to persons licensed or registered or who apply for licensure or  
4.18 registration or who formerly were licensed or registered under the authority of the  
4.19 commissioner of human services or the commissioner of children, youth, and families;

4.20 (2) "client" means a person who is receiving services from a licensee or from an applicant  
4.21 for licensure; and

4.22 (3) "personal and personal financial data" are Social Security numbers, identity of and  
4.23 letters of reference, insurance information, reports from the Bureau of Criminal  
4.24 Apprehension, health examination reports, and social/home studies.

4.25 (b)(1)(i) Except as provided in paragraph (c), the following data on applicants, license  
4.26 holders, certification holders, and former licensees are public: name, address, telephone  
4.27 number of licensees, email addresses except for family child foster care, date of receipt of  
4.28 a completed application, dates of licensure, licensed capacity, type of client preferred,  
4.29 variances granted, record of training and education in child care and child development,  
4.30 type of dwelling, name and relationship of other family members, previous license history,  
4.31 class of license, the existence and status of complaints, and the number of serious injuries  
4.32 to or deaths of individuals in the licensed program as reported to the commissioner of human  
4.33 services; the commissioner of children, youth, and families; the local social services agency;

5.1 or any other county welfare agency. For purposes of this clause, a serious injury is one that  
5.2 is treated by a physician.

5.3 (ii) Except as provided in item (v), when a correction order, an order to forfeit a fine,  
5.4 an order of license suspension, an order of temporary immediate suspension, an order of  
5.5 license revocation, an order of license denial, or an order of conditional license has been  
5.6 issued, or a complaint is resolved, the following data on current and former licensees and  
5.7 applicants are public: the general nature of the complaint or allegations leading to the  
5.8 temporary immediate suspension; the substance and investigative findings of the licensing  
5.9 or maltreatment complaint, licensing violation, or substantiated maltreatment; the existence  
5.10 of settlement negotiations; the record of informal resolution of a licensing violation; orders  
5.11 of hearing; findings of fact; conclusions of law; specifications of the final correction order,  
5.12 fine, suspension, temporary immediate suspension, revocation, denial, or conditional license  
5.13 contained in the record of licensing action; whether a fine has been paid; and the status of  
5.14 any appeal of these actions.

5.15 (iii) When a license denial under section 142A.15 or 245A.05 or a sanction under section  
5.16 142B.18 or 245A.07 is based on a determination that a license holder, applicant, or controlling  
5.17 individual is responsible for maltreatment under section 626.557 or chapter 260E, the identity  
5.18 of the applicant, license holder, or controlling individual as the individual responsible for  
5.19 maltreatment is public data at the time of the issuance of the license denial or sanction.

5.20 (iv) When a license denial under section 142A.15 or 245A.05 or a sanction under section  
5.21 142B.18 or 245A.07 is based on a determination that a license holder, applicant, or controlling  
5.22 individual is disqualified under chapter 245C, the identity of the license holder, applicant,  
5.23 or controlling individual as the disqualified individual is public data at the time of the  
5.24 issuance of the licensing sanction or denial. If the applicant, license holder, or controlling  
5.25 individual requests reconsideration of the disqualification and the disqualification is affirmed,  
5.26 the reason for the disqualification and the reason to not set aside the disqualification are  
5.27 private data.

5.28 (v) A correction order or fine issued to a child care provider for a licensing violation is  
5.29 private data on individuals under section 13.02, subdivision 12, or nonpublic data under  
5.30 section 13.02, subdivision 9, if the correction order or fine is seven years old or older.

5.31 (2) For applicants who withdraw their application prior to licensure or denial of a license,  
5.32 the following data are public: the name of the applicant, the city and county in which the  
5.33 applicant was seeking licensure, the dates of the commissioner's receipt of the initial

6.1 application and completed application, the type of license sought, and the date of withdrawal  
6.2 of the application.

6.3 (3) For applicants who are denied a license, the following data are public: the name and  
6.4 address of the applicant, the city and county in which the applicant was seeking licensure,  
6.5 the dates of the commissioner's receipt of the initial application and completed application,  
6.6 the type of license sought, the date of denial of the application, the nature of the basis for  
6.7 the denial, the existence of settlement negotiations, the record of informal resolution of a  
6.8 denial, orders of hearings, findings of fact, conclusions of law, specifications of the final  
6.9 order of denial, and the status of any appeal of the denial.

6.10 (4) When maltreatment is substantiated under section 626.557 or chapter 260E and the  
6.11 victim and the substantiated perpetrator are affiliated with a program licensed under chapter  
6.12 142B or 245A; the commissioner of human services; commissioner of children, youth, and  
6.13 families; local social services agency; or county welfare agency may inform the license  
6.14 holder where the maltreatment occurred of the identity of the substantiated perpetrator and  
6.15 the victim.

6.16 (5) Notwithstanding clause (1), for child foster care, only the name of the license holder  
6.17 and the status of the license are public if the county attorney has requested that data otherwise  
6.18 classified as public data under clause (1) be considered private data based on the best interests  
6.19 of a child in placement in a licensed program.

6.20 (c) The following are private data on individuals under section 13.02, subdivision 12,  
6.21 or nonpublic data under section 13.02, subdivision 9: personal and personal financial data  
6.22 on family day care program and family foster care program applicants and licensees and  
6.23 their family members who provide services under the license.

6.24 (d) The following are private data on individuals: the identity of persons who have made  
6.25 reports concerning licensees or applicants that appear in inactive investigative data, and the  
6.26 records of clients or employees of the licensee or applicant for licensure whose records are  
6.27 received by the licensing agency for purposes of review or in anticipation of a contested  
6.28 matter. The names of reporters of complaints or alleged violations of licensing standards  
6.29 under chapters 142B, 245A, 245B, 245C, and 245D, and applicable rules and alleged  
6.30 maltreatment under section 626.557 and chapter 260E, are confidential data and may be  
6.31 disclosed only as provided in section 260E.21, subdivision 4; 260E.35; or 626.557,  
6.32 subdivision 12b.

6.33 (e) Data classified as private, confidential, nonpublic, or protected nonpublic under this  
6.34 subdivision become public data if submitted to a court or administrative law judge as part

7.1 of a disciplinary proceeding in which there is a public hearing concerning a license which  
7.2 has been suspended, immediately suspended, revoked, or denied.

7.3 (f) Data generated in the course of licensing investigations that relate to an alleged  
7.4 violation of law are investigative data under subdivision 3.

7.5 (g) Data that are not public data collected, maintained, used, or disseminated under this  
7.6 subdivision that relate to or are derived from a report as defined in section 260E.03, or  
7.7 626.5572, subdivision 18, are subject to the destruction provisions of sections 260E.35,  
7.8 subdivision 6, and 626.557, subdivision 12b.

7.9 (h) Upon request, not public data collected, maintained, used, or disseminated under  
7.10 this subdivision that relate to or are derived from a report of substantiated maltreatment as  
7.11 defined in section 626.557 or chapter 260E may be exchanged with the Department of  
7.12 Health for purposes of completing background studies pursuant to section 144.057 and with  
7.13 the Department of Corrections for purposes of completing background studies pursuant to  
7.14 section 241.021.

7.15 (i) Data on individuals collected according to licensing activities under chapters 142B,  
7.16 245A, and 245C; and data on individuals collected by the commissioner of human services  
7.17 or the commissioner of children, youth, and families according to investigations under  
7.18 section 626.557 and chapters 142B, 245A, 245B, 245C, 245D, and 260E may be shared  
7.19 with the Department of Human Rights, the Department of Health, the Department of  
7.20 Corrections, the ombudsman for mental health and developmental disabilities, and the  
7.21 individual's professional regulatory board and between the commissioners of human services  
7.22 and children, youth, and families when there is reason to believe that laws or standards  
7.23 under the jurisdiction of those agencies may have been violated or the information may  
7.24 otherwise be relevant to the board's regulatory jurisdiction. Background study data on an  
7.25 individual who is the subject of a background study under chapter 245C for a licensed  
7.26 service for which the commissioner of human services or children, youth, and families is  
7.27 the license holder may be shared with the commissioner and the commissioner's delegate  
7.28 by the licensing division. Unless otherwise specified in this chapter, the identity of a reporter  
7.29 of alleged maltreatment or licensing violations may not be disclosed.

7.30 (j) In addition to the notice of determinations required under sections 260E.24,  
7.31 subdivisions 5 and 7, and 260E.30, subdivision 6, paragraphs (b), (c), (d), (e), and (f), if the  
7.32 commissioner of human services; commissioner of children, youth, and families; or the  
7.33 local social services agency has determined that an individual is a substantiated perpetrator  
7.34 of maltreatment of a child based on sexual abuse, as defined in section 260E.03, and the

8.1 commissioner of human services; commissioner of children, youth, and families; or local  
8.2 social services agency knows that the individual is a person responsible for a child's care  
8.3 in another facility, the commissioner of human services; commissioner of children, youth,  
8.4 and families; or local social services agency shall notify the head of that facility of this  
8.5 determination. The notification must include an explanation of the individual's available  
8.6 appeal rights and the status of any appeal. If a notice is given under this paragraph, the  
8.7 government entity making the notification shall provide a copy of the notice to the individual  
8.8 who is the subject of the notice.

8.9 (k) All not public data collected, maintained, used, or disseminated under this subdivision  
8.10 and subdivision 3 may be exchanged between the Department of Human Services, Licensing  
8.11 Division, and the Department of Corrections for purposes of regulating services for which  
8.12 the Department of Human Services and the Department of Corrections have regulatory  
8.13 authority.

8.14 Sec. 5. Minnesota Statutes 2024, section 13.46, subdivision 9, is amended to read:

8.15 Subd. 9. **Fraud.** In cases of suspected fraud, in which access to mental health data  
8.16 maintained by public or private community mental health centers or mental health divisions  
8.17 of counties and other providers under contract to deliver mental health services is necessary  
8.18 to a proper investigation, the county board or the appropriate prosecutorial authority shall  
8.19 refer the matter to the commissioner of human services or the commissioner of children,  
8.20 youth, and families. The commissioner and agents of the commissioner, while maintaining  
8.21 the privacy rights of individuals and families, shall have access to mental health data to  
8.22 conduct an investigation. Upon deeming it appropriate as a result of the investigation, the  
8.23 commissioner shall refer the matter to the appropriate legal authorities and may disseminate  
8.24 to those authorities whatever mental health data are necessary to properly prosecute the  
8.25 case.

10.29 (a) The commissioner, in consultation with the ~~commissioner~~ commissioners of human  
10.30 services and children, youth, and families, shall review and comment on Indian tribe plans  
10.31 submitted to the commissioner for provision of employment and training services. Beginning

11.1 April 15, 1991, and by April 15 of each second year thereafter, the Indian tribe shall prepare  
 11.2 and submit to the commissioner a plan that covers the next two state fiscal years. Beginning  
 11.3 April 15, 1992, and by April 15 of each second year thereafter, the Indian tribe shall prepare  
 11.4 and submit to the commissioner an interim year plan update that deals with performance

**142A.15 PUBLIC ASSISTANCE LIEN ON RECIPIENT'S CAUSE OF ACTION.**

Subdivision 1. **State agency has lien.** When the state agency provides, pays for, or becomes liable for medical care or furnishes subsistence or other payments to a person, the agency shall have a lien for the cost of the care and payments on any and all causes of action or recovery rights under any policy, plan, or contract providing benefits for health care or injury that accrue to the person to whom the care or payments were furnished, or to the person's legal representatives, as a result of the occurrence that necessitated the medical care, subsistence, or other payments. For purposes of this section, "state agency" includes prepaid health plans under contract with the commissioner according to sections 256B.69, 256L.01, subdivision 7, 256L.03, subdivision 6, and 256L.12, and Minnesota Statutes 2009 Supplement, section 256D.03, subdivision 4, paragraph (c); children's mental health collaboratives under section 245.493; demonstration projects for persons with disabilities under section 256B.77; nursing homes reimbursed under chapter 256R; and county-based purchasing entities under section 256B.692.

Subd. 2. **Perfection; enforcement.** (a) The state agency may perfect and enforce its lien under sections 514.69, 514.70, and 514.71, and must file the verified lien statement with the appropriate court administrator in the county of financial responsibility. The verified lien statement must contain the following: the name and address of the person to whom medical care, subsistence, or other payment was furnished; the date of injury; the name and address of vendors furnishing medical care; the dates of the service or payment; the amount claimed to be due for the care or payment; and to the best of the state agency's knowledge, the names and addresses of all persons, firms, or corporations claimed to be liable for damages arising from the injuries.

(b) This section does not affect the priority of any attorney's lien. The state agency is not subject to any limitations period referred to in section 514.69 or 514.71 and has one year from the date notice is first received by it under subdivision 4, paragraph (c), even if the notice is untimely, or one year from the date medical bills are first paid by the state agency, whichever is later, to file its verified lien statement. The state agency may commence an action to enforce the lien within one year of (1) the date the notice required by subdivision 4, paragraph (c), is received, or (2) the date the person's cause of action is concluded by judgment, award, settlement, or otherwise, whichever is later.

(c) If the notice required in subdivision 4 is not provided by any of the parties to the claim at any stage of the claim, the state agency will have one year from the date the state agency learns of the lack of notice to commence an action. If amounts on the claim or cause of action are paid and the amount required to be paid to the state agency under subdivision 5 is not paid to the state agency, the state agency may commence an action to recover on the lien against any or all of the parties or entities that have either paid or received the payments.

Subd. 3. **Prosecutor.** (a) The attorney general shall represent the commissioner to enforce the lien created under this section or, if no action has been brought, may initiate and prosecute an independent action on behalf of the commissioner against a person, firm, or corporation that may be liable to the person to whom the care or payment was furnished.

(b) Any prepaid health plan providing services under sections 256B.69 and 256L.12 and Minnesota Statutes 2009 Supplement, section 256D.03, subdivision 4, paragraph (c); children's mental health collaboratives under section 245.493; demonstration projects for persons with disabilities under section 256B.77; nursing homes reimbursed under chapter 256R; or the county-based purchasing entity providing services under section 256B.692 may retain legal representation to enforce their lien created under this section or, if no action has been brought, may initiate and prosecute an independent action on their behalf against a person, firm, or corporation that may be liable to the person to whom the care or payment was furnished.

Subd. 4. **Notice.** (a) The state agency must be given notice of monetary claims against a person, firm, or corporation that may be liable in damages to the injured person when the state agency has paid for or become liable for the cost of medical care or payments related to the injury. Notice must be given as provided in this subdivision.

(b) Applicants for public assistance shall notify the state or county agency of any possible claims they may have against a person, firm, or corporation when they submit the application for assistance. Recipients of public assistance shall notify the state or county agency of any possible claims when those claims arise.

(c) A person providing medical care services to a recipient of public assistance shall notify the state agency when the person has reason to believe that a third party may be liable for payment of the cost of medical care.

(d) A party to a claim upon which the state agency may be entitled to a lien under this section shall notify the state agency of its potential lien claim at each of the following stages of a claim:

- (1) when a claim is filed;
- (2) when an action is commenced; and
- (3) when a claim is concluded by payment, award, judgment, settlement, or otherwise.

(e) Every party involved in any stage of a claim under this subdivision is required to provide notice to the state agency at that stage of the claim. However, when one of the parties to the claim provides notice at that stage, every other party to the claim is deemed to have provided the required notice at that stage of the claim. If the required notice under this paragraph is not provided to the state agency, every party will be deemed to have failed to provide the required notice. A party to a claim includes the injured person or the person's legal representative, the plaintiff, the defendants, or persons alleged to be responsible for compensating the injured person or plaintiff, and any other party to the cause of action or claim, regardless of whether the party knows the state agency has a potential or actual lien claim.

(f) Notice given to the county agency is not sufficient to meet the requirements of paragraphs (c) and (d).

**Subd. 5. Costs deducted.** Upon any judgment, award, or settlement of a cause of action, or any part of it, upon which the state agency has filed its lien, including compensation for liquidated, unliquidated, or other damages, reasonable costs of collection, including attorney fees, must be deducted first. The full amount of public assistance paid to or on behalf of the person as a result of the injury must be deducted next, and paid to the state agency. The rest must be paid to the public assistance recipient or other plaintiff. The plaintiff, however, must receive at least one-third of the net recovery after attorney fees and other collection costs.

**Subd. 6. When effective.** The lien created under this section is effective with respect to any public assistance paid on or after August 1, 1987.

**Subd. 7. Cooperation with information requests required.** (a) Upon the request of the commissioner:

(1) any state agency or third-party payer shall cooperate by furnishing information to help establish a third-party liability, as required by the federal Deficit Reduction Act of 2005, Public Law 109-171;

(2) any employer or third-party payer shall cooperate by furnishing a data file containing information about group health insurance plan or medical benefit plan coverage of its employees or insureds within 60 days of the request. The information in the data file must include at least the following: full name, date of birth, Social Security number if collected and stored in a system routinely used for producing data files by the employer or third-party payer, employer name, policy identification number, group identification number, and plan or coverage type.

(b) For purposes of section 176.191, subdivision 4, the commissioner of labor and industry may allow the commissioner of children, youth, and families and county agencies direct access and data matching on information relating to workers' compensation claims in order to determine whether the claimant has reported the fact of a pending claim and the amount paid to or on behalf of the claimant to the commissioner of human services.

(c) For the purpose of compliance with section 169.09, subdivision 13, and federal requirements under Code of Federal Regulations, title 42, section 433.138(d)(4), the commissioner of public safety shall provide accident data as requested by the commissioner of children, youth, and families. The disclosure shall not violate section 169.09, subdivision 13, paragraph (d).

(d) The commissioner of children, youth, and families and county agencies shall limit its use of information gained from agencies, third-party payers, and employers to purposes directly connected with the administration of its public assistance and child support programs. The provision of information by agencies, third-party payers, and employers to the department under this subdivision is not a violation of any right of confidentiality or data privacy.

The commissioner of human services shall promulgate rules in accordance with chapter 14, prescribing minimum standards of eligibility and payment for poor relief, which shall recognize cost of living differences in the various counties of the state.
