1.8	<u>RESPONSE,</u> OR FIREFIGHTING.
1.9	Subdivision 1. Crime. Whoever intentionally knowingly does any of the following
1.10	may be sentenced as provided in subdivision 2:
1.11	(1) obstructs, hinders, or prevents the lawful execution of any legal process, civil or
1.12	criminal, or apprehension of another on a charge or conviction of a criminal offense;
1.13	(2) obstructs, resists, or interferes with a peace officer or reserve officer while the
1.14	officer is engaged in the performance of official duties;
1.15	(3) interferes with or obstructs a firefighter while the firefighter is engaged in the
1.16	performance of official duties;
1.17	(4) interferes with or obstructs a member of an ambulance service personnel crew,
