1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2012, section 127A.70, subdivision 1, is amended to read: 1.7 Subdivision 1. Establishment; membership. (a) A P-20 education partnership is 18 established to create a seamless system of education that maximizes achievements of 1.9 all students, from early childhood through elementary, secondary, and postsecondary 1.10 education, while promoting the efficient use of financial and human resources. The 1 11 partnership shall consist of major statewide educational groups or constituencies or 1.12 noneducational statewide organizations with a stated interest in P-20 education including a 1.13 representative appointed by the adjutant general of the Minnesota National Guard, among 1.14 other organizations. The initial membership of the partnership includes the members 1.15 serving on the Minnesota P-16 Education Partnership and four legislators appointed as 1.16 follows: 1 17 (1) one senator from the majority party and one senator from the minority party, 1.18 appointed by the Subcommittee on Committees of the Committee on Rules and 1 19 Administration; and 1 20 (2) one member of the house of representatives appointed by the speaker of the 1.21 house and one member appointed by the minority leader of the house of representatives. 1.22 (b) The chair of the P-16 education partnership must convene the first meeting 1.23 of the P-20 partnership. Prospective members may be nominated by any partnership 1.24 member and new members will be added with the approval of a two-thirds majority of the 1.25

- 2.1 partnership. The partnership will also seek input from nonmember organizations whose2.2 expertise can help inform the partnership's work.
- (c) Partnership members shall be represented by the chief executives, presidents, or
   other formally designated leaders of their respective organizations, or their designees. The
   partnership shall meet at least three times during each calendar year.
