1.16 We, the undersigned conferees for H. F. No. 2576 report that we have agreed upon
1.17 the items in dispute and recommend as follows:

1.18 That the Senate recede from its amendments and that H. F. No. 2576 be further
1.19 amended as follows:

1.20 Delete everything after the enacting clause and insert:

1.21 "Section 1. Minnesota Statutes 2012, section 245C.22, subdivision 7, is amended to
1.22 read:

1.23 Subd. 7. **Classification of certain data.** (a) Notwithstanding section 13.46, except
1.24 as provided in paragraph (f), upon setting aside a disqualification under this section, the
1.25 identity of the disqualified individual who received the set-aside and the individual's
1.26 disqualifying characteristics are public data if the set-aside was:

1.27 (1) for any disqualifying characteristic under section 245C.15, when the set-aside
1.28 relates to a child care center or a family child care provider licensed under chapter 245A; or

1.29 (2) for a disqualifying characteristic under section 245C.15, subdivision 2.

1.30 (b) Notwithstanding section 13.46, upon granting a variance to a license holder
1.31 under section 245C.30, the identity of the disqualified individual who is the subject of

2.1 the variance, the individual's disqualifying characteristics under section 245C.15, and the
2.2 terms of the variance are public data, when the variance:

2.3 (1) is issued to a child care center or a family child care provider licensed under
2.4 chapter 245A; or

2.5 (2) relates to an individual with a disqualifying characteristic under section 245C.15,
2.6 subdivision 2.

2.7 (c) The identity of a disqualified individual and the reason for disqualification
2.8 remain private data when:

2.9 (1) a disqualification is not set aside and no variance is granted, except as provided
2.10 under section 13.46, subdivision 4;

2.11 (2) the data are not public under paragraph (a) or (b);

2.12 (3) the disqualification is rescinded because the information relied upon to disqualify
2.13 the individual is incorrect;

2.14 (4) the disqualification relates to a license to provide relative child foster care.

2.15 As used in this clause, "relative" has the meaning given it under section 260C.007,
2.16 subdivision 27; or

2.17 (5) the disqualified individual is a household member of a licensed foster care
2.18 provider and:

2.19 (i) the disqualified individual previously received foster care services from this
2.20 licensed foster care provider;

2.21 (ii) the disqualified individual was subsequently adopted by this licensed foster
2.22 care provider; and

2.23 (iii) the disqualifying act occurred before the adoption.

2.24 (d) Licensed family child care providers and child care centers must provide notices
2.25 as required under section 245C.301.

2.26 (e) Notwithstanding paragraphs (a) and (b), the identity of household members who
2.27 are the subject of a disqualification related set-aside or variance is not public data if:

2.28 (1) the household member resides in the residence where the family child care is
2.29 provided;

2.30 (2) the subject of the set-aside or variance is under the age of 18 years; and

2.31 (3) the set-aside or variance only relates to a disqualification under section 245C.15,
2.32 subdivision 4, for a misdemeanor-level theft crime as defined in section 609.52.

2.33 (f) When the commissioner has reason to know that a disqualified individual has
2.34 received an order for expungement for the disqualifying record that does not limit the
2.35 commissioner's access to the record, and the record was opened or exchanged with the

3.1 commissioner for purposes of a background study under this chapter, the data that would
3.2 otherwise become public under paragraph (a) or (b) remain private data.

3.4 Subdivision 1. **Disqualification that is rescinded or set aside.** (a) If the
3.5 commissioner rescinds or sets aside a disqualification, the commissioner shall notify the
3.6 applicant, license holder, or other entity in writing or by electronic transmission of the
3.7 decision.

3.8 (b) In the notice from the commissioner that a disqualification has been rescinded,
3.9 the commissioner must inform the applicant, license holder, or other entity that the
3.10 information relied upon to disqualify the individual was incorrect.

3.11 (c) Except as provided in paragraph (d), in the notice from the commissioner
3.12 that a disqualification has been set aside, the commissioner must inform the applicant,
3.13 license holder, or other entity of the reason for the individual's disqualification and that
3.14 information about which factors under section 245C.22, subdivision 4, were the basis
3.15 of the decision to set aside the disqualification are available to the license holder upon
3.16 request without the consent of the background study subject.

3.17 (d) When the commissioner has reason to know that a disqualified individual has
3.18 received an order for expungement for the disqualifying record that does not limit the
3.19 commissioner's access to the record, and the record was opened or exchanged with the
3.20 commissioner for purposes of a background study under this chapter, the information
3.21 provided under paragraph (c) must only inform the applicant, license holder, or other
3.22 entity that the disqualifying criminal record is sealed under a court order.

3.24 Subd. 6. **Expungement.** ~~Except when legal custody is transferred under the~~
3.25 ~~provisions of subdivision 1, clause (4),~~ (a) The court may expunge the adjudication
3.26 of all records relating to delinquency at any time that it deems advisable if the court
3.27 determines that expungement of the record would yield a benefit to the subject of the
3.28 record that outweighs the detriment to the public and public safety in sealing the record
3.29 and the burden on the court and public agencies or jurisdictions in issuing, enforcing,
3.30 and monitoring the order.

3.31 (b) In making a determination under this subdivision, the court shall consider:

3.32 (1) the age, education, experience, and background, including mental and emotional
3.33 development, of the subject of the record at the time of commission of the offense;

- 4.1 (2) the circumstances and nature and severity of the offense, including any
4.2 aggravating or mitigating factors in the commission of the offense;
- 4.3 (3) victim and community impact, including age and vulnerability of the victim;
- 4.4 (4) the level of participation of the subject of the record in the planning and carrying
4.5 out of the offense, including familial or peer influence in the commission of the offense;
- 4.6 (5) the juvenile delinquency and criminal history of the subject of the record;
- 4.7 (6) the programming history of the subject of the record, including child welfare,
4.8 school and community-based, and probation interventions, and the subject's willingness to
4.9 participate meaningfully in programming, probation, or both;
- 4.10 (7) any other aggravating or mitigating circumstance bearing on the culpability or
4.11 potential for rehabilitation of the subject of the record; and
- 4.12 (8) the benefit that expungement would yield to the subject of the record in pursuing
4.13 education, employment, housing, or other necessities.
- 4.14 (c) A record expunged under this subdivision prior to the effective date of this act
4.15 may not be opened or exchanged. A record expunged under this subdivision on or after
4.16 the effective date of this act is sealed and access only allowed pursuant to paragraph (d).
- 4.17 (d) Notwithstanding paragraph (a), a record that is expunged under this subdivision
4.18 on or after the effective date of this act may be opened, used, or exchanged between
4.19 criminal justice agencies in the same manner as a criminal record under section 609A.03,
4.20 subdivision 7a, paragraph (b).
- 4.21 (e) Section 609A.03, subdivision 3, paragraph (d), applies to the disclosure of private
4.22 or confidential data in a proceeding under this subdivision. Section 609A.03, subdivision
4.23 9, applies to an appeal of an order under this subdivision.

4.31 Subdivision 1. **General.** (a) If the court or jury finds for the plaintiff, the court shall
4.32 immediately enter judgment that the plaintiff shall have recovery of the premises, and shall
4.33 tax the costs against the defendant. The court shall issue execution in favor of the plaintiff
4.34 for the costs and also immediately issue a writ of recovery of premises and order to vacate.

5.1 (b) The court shall give priority in issuing a writ of recovery of premises and order
5.2 to vacate for an eviction action brought under section 504B.171 or on the basis that the
5.3 tenant is causing a nuisance or seriously endangers the safety of other residents, their
5.4 property, or the landlord's property.

5.6 (1) the court shall enter judgment for the defendant, tax the costs against the plaintiff,

8.13 (a) If the prosecutor agrees to the sealing of a criminal record, the court shall seal the
8.14 criminal record for a person described in section 609A.02, subdivision 3, without the filing
8.15 of a petition unless it determines that the interests of the public and public safety in keeping
8.16 the record public outweigh the disadvantages to the subject of the record in not sealing it.

8.17 (b) Before agreeing to the sealing of a record under this section, the prosecutor shall
8.18 make a good faith effort to notify any identifiable victims of the offense of the intended
8.19 agreement and the opportunity to object to the agreement.

8.20 (c) Subject to paragraph (b), the agreement of the prosecutor to the sealing of records
8.21 for a person described in section 609A.02, subdivision 3, paragraph (a), clause (2), may
8.22 occur before or after the criminal charges are dismissed.

8.23 **EFFECTIVE DATE.** This section is effective January 1, 2015.

8.25 Subdivision 1. **Petition; filing fee.** An individual who is the subject of a criminal
8.26 record who is seeking the expungement of the record shall file a petition under this section
8.27 and pay a filing fee in the amount required under section 357.021, subdivision 2, clause
8.28 (1). The filing fee may be waived in cases of indigency and shall be waived in the cases
8.29 described in section 609A.02, subdivision 3, paragraph (a), clause (1).

8.30 **EFFECTIVE DATE.** This section is effective January 1, 2015.

8.31 Sec. 9. Minnesota Statutes 2012, section 609A.03, subdivision 3, is amended to read:

9.1 Subd. 3. **Service of petition and proposed order.** (a) The petitioner shall serve by
9.2 mail the petition for expungement and a proposed expungement order on the prosecutorial
9.3 office that had jurisdiction over the offense for which expungement is sought and all
9.4 other state and local government agencies and jurisdictions whose records would be
9.5 affected by the proposed order. The petitioner shall also serve by mail the attorney for
9.6 each agency and jurisdiction.

9.7 (b) The prosecutorial office that had jurisdiction over the offense for which
9.8 expungement is sought shall serve by mail the petition for expungement and a proposed
9.9 expungement order on any victims of the offense for which expungement is sought who
9.10 have requested notice of expungement pursuant to section 611A.06. Service under this
9.11 paragraph does not constitute a violation of an existing order for protection, restraining
9.12 order, or other no contact order.

9.13 (c) The prosecutorial office's notice to victims of the offense under this subdivision
9.14 must specifically inform the victims of the victims' right to be present and to submit an
9.15 oral or written statement at the expungement hearing described in subdivision 4.

9.16 (d) An agency or jurisdiction that is served with a petition under this subdivision
9.17 may submit to the court private or confidential data on the petitioner that the agency or
9.18 jurisdiction determines is necessary to respond to the petition. As part of the submission,
9.19 the agency or jurisdiction shall inform the court and the petitioner that the submission
9.20 contains private or confidential data that may become accessible to the public as part of
9.21 the expungement proceeding. The petitioner may, at the time of filing the petition or after
9.22 that time, file a request with the court to seal the private or confidential data that are
9.23 submitted by the agency or jurisdiction.

9.24 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.26 Subd. 5. **Nature of remedy; standard.** (a) Except as otherwise provided by
9.27 paragraph (b), expungement of a criminal record is an extraordinary remedy to be granted
9.28 only upon clear and convincing evidence that it would yield a benefit to the petitioner
9.29 commensurate with the disadvantages to the public and public safety of:

9.30 (1) sealing the record; and

9.31 (2) burdening the court and public authorities to issue, enforce, and monitor an
9.32 expungement order.

9.33 (b) Except as otherwise provided by this paragraph, if the petitioner is petitioning
9.34 for the sealing of a criminal record under section 609A.02, subdivision 3, paragraph (a),
9.35 clause (1) or (2), the court shall grant the petition to seal the record unless the agency

10.1 or jurisdiction whose records would be affected establishes by clear and convincing
10.2 evidence that the interests of the public and public safety outweigh the disadvantages
10.3 to the petitioner of not sealing the record.

10.4 (c) In making a determination under this subdivision, the court shall consider:

10.5 (1) the nature and severity of the underlying crime, the record of which would
10.6 be sealed;

10.7 (2) the risk, if any, the petitioner poses to individuals or society;

10.8 (3) the length of time since the crime occurred;

10.9 (4) the steps taken by the petitioner toward rehabilitation following the crime;

10.10 (5) aggravating or mitigating factors relating to the underlying crime, including the
10.11 petitioner's level of participation and context and circumstances of the underlying crime;

10.12 (6) the reasons for the expungement, including the petitioner's attempts to obtain
10.13 employment, housing, or other necessities;

10.14 (7) the petitioner's criminal record;

10.15 (8) the petitioner's record of employment and community involvement;

10.16 (9) the recommendations of interested law enforcement, prosecutorial, and
10.17 corrections officials;

10.18 (10) the recommendations of victims or whether victims of the underlying crime
10.19 were minors;

10.20 (11) the amount, if any, of restitution outstanding, past efforts made by the petitioner
10.21 toward payment, and the measures in place to help ensure completion of restitution
10.22 payment after expungement of the record if granted; and

10.23 (12) other factors deemed relevant by the court.

10.24 (e) (d) Notwithstanding section 13.82, 13.87, or any other law to the contrary, if the
10.25 court issues an expungement order it may require that the criminal record be sealed, the
10.26 existence of the record not be revealed, and the record not be opened except as required
10.27 under subdivision 7. Records must not be destroyed or returned to the subject of the record.

10.28 (e) Information relating to a criminal history record of an employee, former
10.29 employee, or tenant that has been expunged before the occurrence of the act giving rise
10.30 to the civil action may not be introduced as evidence in a civil action against a private
10.31 employer or landlord or its employees or agents that is based on the conduct of the
10.32 employee, former employee, or tenant.

10.33 **EFFECTIVE DATE.** This section is effective January 1, 2015.

10.34 Sec. 11. Minnesota Statutes 2012, section 609A.03, is amended by adding a
10.35 subdivision to read:

11.1 **Subd. 6a. Order when context and circumstances of the underlying crime**
11.2 **indicate a nexus between the criminal record to be expunged and person's status as a**
11.3 **crime victim.** If the court finds, under section 609A.03, subdivision 5, paragraph (c), clause
11.4 (5), that the context and circumstances of the underlying crime indicate a nexus between
11.5 the criminal record to be expunged and the person's status as a crime victim, then the effect
11.6 of the court order to seal the record of the proceedings shall be to restore the person, in the
11.7 contemplation of the law, to the status the person occupied before the arrest, indictment,
11.8 or information. The person shall not be guilty of perjury or otherwise of giving a false
11.9 statement if the person fails to acknowledge the arrest, indictment, information, or trial in
11.10 response to any inquiry made for any purpose. The court may request a sworn statement
11.11 from a staff member of a state-funded victim services organization or a licensed health
11.12 care provider as evidence to support a determination under section 609A.03, subdivision 5.

11.13 **EFFECTIVE DATE.** This section is effective January 1, 2015.

11.15 **Subd. 7. Limitations of order.** (a) Upon issuance of an expungement order related
