as a STEMI receiving center for a three-year period. If a hospital loses its accreditation as a STEMI receiving center from a nationally recognized accreditation entity, its Minnesota designation shall be immediately withdrawn.

Sec. 2. Minnesota Statutes 2014, section 144E.16, is amended by adding a subdivision to read:

Subd. 8. **STEMI transport protocols.** Regional and local emergency medical services programs must develop STEMI transport protocols. The protocols must include standards of care for triage and transport of STEMI patients within a specific time frame from first medical contact until transport to the most appropriate hospital, based on the patient's condition, the time of transport, and the hospital's capabilities.
