1.1 A bill for an act

relating to capital investment; appropriating money for New American Centers capital and operating purposes; authorizing the sale and issuance of state bonds.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. NEW AMERICAN CENTERS.

Subdivision 1. Capital project grants. \$20,000,000 is appropriated from the bond proceeds fund to the commissioner of employment and economic development to make four grants to political subdivisions in areas outside the seven-county metropolitan area to acquire real property, predesign, design, construct, renovate, furnish, and equip four New American Centers. The centers must be in geographically dispersed locations in the state. A political subdivision may apply to the commissioner for a grant at the time, on a form, and in a manner prescribed by the commissioner. A grantee may enter into a lease or management agreement to operate the program in the center, subject to Minnesota Statutes, section 16A.695. In addition to any other criteria the commissioner determines necessary or useful, the commissioner shall give priority to applications from political subdivisions that will provide a nonstate contribution to the project, are located in regions that have a demonstrated need for a center based on demographic data, have developed programs providing outreach to recent immigrants, and are engaging in new Americans' community cultural events.

Subd. 2. **Operations funding.** \$...... in fiscal year 2018 is appropriated from the general fund to the commissioner of employment and economic development for grants to the New American Centers to provide a one-stop shop to help recent immigrants access jobs, education, health care, and other services, in partnership with local governments, school
