1.13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.14 ARTICLE 1

1.15 HEALTH CARE

1.16 Section 1. Minnesota Statutes 2010, section 62J.497, subdivision 2, is amended to read:

1.17 Subd. 2. Requirements for electronic prescribing. (a) Effective January 1, 2011,
1.18 all providers, group purchasers, prescribers, and dispensers must establish, maintain,
1.19 and use an electronic prescription drug program. This program must comply with the
1.20 applicable standards in this section for transmitting, directly or through an intermediary,
1.21 prescriptions and prescription-related information using electronic media.

1.22 (b) If transactions described in this section are conducted, they must be done
1.23 electronically using the standards described in this section. Nothing in this section
1.24 requires providers, group purchasers, prescribers, or dispensers to electronically conduct
1.25 transactions that are expressly prohibited by other sections or federal law.

1.26 (c) Providers, group purchasers, prescribers, and dispensers must use either HL7
1.27 messages or the NCPDP SCRIPT Standard to transmit prescriptions or prescription-related

2.1 information internally when the sender and the recipient are part of the same legal entity. If
2.2 an entity sends prescriptions outside the entity, it must use the NCPDP SCRIPT Standard
2.3 or other applicable standards required by this section. Any pharmacy within an entity
2.4 must be able to receive electronic prescription transmittals from outside the entity using
2.5 the adopted NCPDP SCRIPT Standard. This exemption does not supersede any Health
2.6 Insurance Portability and Accountability Act (HIPAA) requirement that may require the
2.7 use of a HIPAA transaction standard within an organization.

2.8 (d) Notwithstanding paragraph (a), any clinic with two or fewer practicing
2.9 physicians is exempt from this subdivision if the clinic is making a good-faith effort to
2.10 meet the electronic health records system requirement under section 62J.495 that includes
2.11 an electronic prescribing component. This paragraph expires January 1, 2015.

2.12 **EFFECTIVE DATE.** This section is effective retroactively from January 1, 2011.

2.14 Subdivision 1. **Electronic claims and eligibility transactions required.** (a)
2.15 Beginning January 15, 2009, all group purchasers must accept from health care providers
2.16 the eligibility for a health plan transaction described under Code of Federal Regulations,
2.17 title 45, part 162, subpart L. Beginning July 15, 2009, all group purchasers must accept
2.18 from health care providers the health care claims or equivalent encounter information
2.19 transaction described under Code of Federal Regulations, title 45, part 162, subpart K.

2.20 (b) Beginning January 15, 2009, all group purchasers must transmit to providers the
2.21 eligibility for a health plan transaction described under Code of Federal Regulations, title
2.22 45, part 162, subpart L. Beginning December 15, 2009, all group purchasers must transmit
2.23 to providers the health care payment and remittance advice transaction described under
2.24 Code of Federal Regulations, title 45, part 162, subpart P.

2.25 (c) Beginning January 15, 2009, all health care providers must submit to group
2.26 purchasers the eligibility for a health plan transaction described under Code of Federal
2.27 Regulations, title 45, part 162, subpart L. Beginning July 15, 2009, all health care
2.28 providers must submit to group purchasers the health care claims or equivalent encounter
2.29 information transaction described under Code of Federal Regulations, title 45, part 162,
2.30 subpart K.

2.31 (d) Beginning January 15, 2009, all health care providers must accept from group
2.32 purchasers the eligibility for a health plan transaction described under Code of Federal
2.33 Regulations, title 45, part 162, subpart L. Beginning December 15, 2009, all health care
2.34 providers must accept from group purchasers the health care payment and remittance

3.1 advice transaction described under Code of Federal Regulations, title 45, part 162, subpart
3.2 P.

3.3 (e) Beginning January 1, 2012, all health care providers, health care clearinghouses,
3.4 and group purchasers must provide an appropriate, standard, electronic acknowledgment
3.5 when receiving the health care claims or equivalent encounter information transaction or
3.6 the health care payment and remittance advice transaction. The acknowledgment provided
3.7 must be based on one or more of the following American National Standards Institute,
3.8 Accredited Standards Committee X12 standard transactions:

- 3.9 (1) TA1;
3.10 (2) ~~997~~;
3.11 ~~(3)~~ 999; or
3.12 ~~(4)~~ (3) 277CA.

3.13 Health care providers, health care clearinghouses, and group purchasers ~~may send and~~
3.14 ~~receive more than one type of standard acknowledgment as mutually agreed upon. The~~
3.15 ~~mutually agreed upon acknowledgments must be exchanged electronically using one of~~
3.16 the National Council for Prescription Drug Program (NCPDP) standards must use the
3.17 appropriate NCPDP response standard as the electronic acknowledgment. Electronic
3.18 exchanges of acknowledgments do not include e-mail or facsimile.

3.19 (f) Each of the transactions described in paragraphs (a) to (e) shall require the use
3.20 of a single, uniform companion guide to the implementation guides described under
3.21 Code of Federal Regulations, title 45, part 162. The companion guides will be developed
3.22 pursuant to subdivision 2.

3.23 (g) Notwithstanding any other provisions in sections 62J.50 to 62J.61, all group
3.24 purchasers and health care providers must exchange claims and eligibility information
3.25 electronically using the transactions, companion guides, implementation guides, and
3.26 timelines required under this subdivision. Group purchasers may not impose any fee on
3.27 providers or providers' clearinghouses for the use of the transactions prescribed in this
3.28 subdivision. Health care providers may not impose a fee on group purchasers or group
3.29 purchasers' clearinghouses for the use of the transactions prescribed in this subdivision.
3.30 A clearinghouse may not charge a fee solely to receive a standard transaction from a
3.31 health care provider, a health care provider's clearinghouse, a group purchaser, or a group
3.32 purchaser's clearinghouse when it is not an agent of the sending entity. A clearinghouse
3.33 may not charge a fee solely to send a standard transaction to a health care provider, a health
3.34 care provider's clearinghouse, a group purchaser, or a group purchaser's clearinghouse
3.35 when it is not an agent of the receiving entity.

4.1 (h) Nothing in this subdivision shall prohibit group purchasers and health care
4.2 providers from using a direct data entry, Web-based methodology for complying with
4.3 the requirements of this subdivision. Any direct data entry method for conducting
4.4 the transactions specified in this subdivision must be consistent with the data content
4.5 component of the single, uniform companion guides required in paragraph (f) and the
4.6 implementation guides described under Code of Federal Regulations, title 45, part 162.

4.7 **EFFECTIVE DATE.** This section is effective July 1, 2012.

4.9 to read:

4.10 **Subd. 8. Coverage dates.** The commissioner, upon the request of a managed care
4.11 or county-based purchasing plan, shall include the end of coverage dates on the monthly
4.12 rosters of medical assistance and MinnesotaCare enrollees provided to the plans. The
4.13 commissioner may assess plans a fee for the cost of producing the monthly roster of
4.14 enrollees with end of coverage dates.

4.16 HUMAN SERVICES

4.17 Section 1. Minnesota Statutes 2010, section 256.0112, is amended by adding a
4.18 subdivision to read:

4.19 **Subd. 9. Contracting for performance.** In addition to the agreements in
4.20 subdivision 8, a local agency may negotiate a supplemental agreement to a contract
4.21 executed between a lead agency and an approved vendor under subdivision 6 for the
4.22 purposes of contracting for specific performance. The supplemental agreement may
4.23 augment the lead contract requirements and rates for services authorized by that local
4.24 agency only. The additional provisions must be negotiated with the vendor and designed
4.25 to encourage successful, timely, and cost-effective outcomes for clients, and may establish
4.26 incentive payments, penalties, performance-related reporting requirements, and similar
4.27 conditions. The per diem rate allowed under this subdivision must not be less than the rate
4.28 established in the lead county contract. Nothing in the supplemental agreement between
4.29 a local agency and an approved vendor binds the lead agency or other local agencies to
4.30 the terms and conditions of the supplemental agreement.

5.1 Subdivision 1. **Purpose.** ~~(a) The~~ Family stabilization services serve families who
 5.2 are not making significant progress within the regular employment and training services
 5.3 track of the Minnesota family investment program (MFIP) due to a variety of barriers to
 5.4 employment.

5.5 ~~(b) The goal of the services is to stabilize and improve the lives of families at risk~~

5.34 Sec. 4. Minnesota Statutes 2010, section 256J.575, subdivision 5, is amended to read:

6.1 Subd. 5. ~~Case management; Family stabilization plans; coordinated services.~~

6.2 (a) The county agency or employment services provider shall provide ~~family stabilization~~
6.3 ~~services to families through a case management model. A case manager shall be assigned~~
6.4 ~~to each participating family within 30 days after the family is determined to be eligible~~
6.5 ~~for family stabilization services. The case manager, with the full involvement of the~~
6.6 ~~participant, shall recommend, and the county agency shall establish and modify as~~
6.7 ~~necessary, a family stabilization plan for each participating family. Once a participant~~
6.8 ~~has been determined eligible for family stabilization services, the county agency or~~
6.9 ~~employment services provider must attempt to meet with the participant to develop a~~

6.23 (c) ~~The case manager and the participant shall meet within 30 days of the family's~~

7.5 Subd. 6. **Cooperation with services requirements.** ~~(a) A participant who is eligible~~

7.7 ~~(b) Participants shall engage in family stabilization plan services for the appropriate~~

7.22 Subd. 8. **Funding.** (a) The commissioner of human services shall treat MFIP
7.23 expenditures made to or on behalf of any minor child under this section, who is part of a
7.24 household that meets criteria in subdivision 3, as expenditures under a separately funded
7.25 state program. These expenditures shall not count toward the state's maintenance of effort
7.26 requirements under the federal TANF program.

7.28 the caregiver no longer meets the criteria for family stabilization services in subdivision

8.1 The commissioner of human services shall initiate procedures no later than October
8.2 1, 2012, to enter into a reciprocal agreement with Bermuda for the establishment and
8.3 enforcement of child support obligations under United States Code, title 42, section
8.4 659a(d).

8.5 **EFFECTIVE DATE.** This section is effective upon Bermuda's written acceptance
8.6 and agreement to enforce Minnesota child support orders. If Bermuda does not accept and
8.7 declines to enforce Minnesota orders, this section expires December 31, 2013.

8.10 Section 1. Minnesota Statutes 2011 Supplement, section 256B.0911, subdivision 3a,
8.11 is amended to read:

8.12 Subd. 3a. **Assessment and support planning.** (a) Persons requesting assessment,
8.13 services planning, or other assistance intended to support community-based living,
8.14 including persons who need assessment in order to determine waiver or alternative care
8.15 program eligibility, must be visited by a long-term care consultation team within 15
8.16 calendar days after the date on which an assessment was requested or recommended. After
8.17 January 1, 2011, these requirements also apply to personal care assistance services, private
8.18 duty nursing, and home health agency services, on timelines established in subdivision 5.
8.19 Face-to-face assessments must be conducted according to paragraphs (b) to (i).

8.20 (b) The county may utilize a team of either the social worker or public health nurse,
8.21 or both. After January 1, 2011, lead agencies shall use certified assessors to conduct the
8.22 assessment in a face-to-face interview. The consultation team members must confer
8.23 regarding the most appropriate care for each individual screened or assessed.

8.24 (c) The assessment must be comprehensive and include a person-centered
8.25 assessment of the health, psychological, functional, environmental, and social needs of
8.26 referred individuals and provide information necessary to develop a support plan that
8.27 meets the consumers needs, using an assessment form provided by the commissioner.

8.28 (d) The assessment must be conducted in a face-to-face interview with the person
8.29 being assessed and the person's legal representative, as required by legally executed
8.30 documents, and other individuals as requested by the person, who can provide information
8.31 on the needs, strengths, and preferences of the person necessary to develop a support plan
8.32 that ensures the person's health and safety, but who is not a provider of service or has any
8.33 financial interest in the provision of services. For persons who are to be assessed for
8.34 elderly waiver customized living services under section 256B.0915, with the permission

9.1 of the person being assessed or the person's designated or legal representative, the client's
9.2 current or proposed provider of services may submit a copy of the provider's nursing
9.3 assessment or written report outlining its recommendations regarding the client's care
9.4 needs. The person conducting the assessment will notify the provider of the date by which
9.5 this information is to be submitted. This information shall be provided to the person
9.6 conducting the assessment prior to the assessment.

9.7 (e) The person, or the person's legal representative, must be provided with written
9.8 recommendations for community-based services, including consumer-directed options,
9.9 or institutional care that include documentation that the most cost-effective alternatives
9.10 available were offered to the individual, and alternatives to residential settings, including,
9.11 but not limited to, foster care settings that are not the primary residence of the license
9.12 holder. For purposes of this requirement, "cost-effective alternatives" means community
9.13 services and living arrangements that cost the same as or less than institutional care.

9.14 (f) If the person chooses to use community-based services, the person or the person's
9.15 legal representative must be provided with a written community support plan, regardless
9.16 of whether the individual is eligible for Minnesota health care programs. A person may
9.17 request assistance in identifying community supports without participating in a complete
9.18 assessment. Upon a request for assistance identifying community support, the person must
9.19 be transferred or referred to the services available under sections 256.975, subdivision 7,
9.20 and 256.01, subdivision 24, for telephone assistance and follow up.

9.21 (g) The person has the right to make the final decision between institutional
9.22 placement and community placement after the recommendations have been provided,
9.23 except as provided in subdivision 4a, paragraph (c).

9.24 (h) The team must give the person receiving assessment or support planning, or
9.25 the person's legal representative, materials, and forms supplied by the commissioner
9.26 containing the following information:

9.27 (1) the need for and purpose of preadmission screening if the person selects nursing
9.28 facility placement;

9.29 (2) the role of the long-term care consultation assessment and support planning in
9.30 waiver and alternative care program eligibility determination;

9.31 (3) information about Minnesota health care programs;

9.32 (4) the person's freedom to accept or reject the recommendations of the team;

9.33 (5) the person's right to confidentiality under the Minnesota Government Data
9.34 Practices Act, chapter 13;

10.1 (6) the long-term care consultant's decision regarding the person's need for
10.2 institutional level of care as determined under criteria established in section 144.0724,
10.3 subdivision 11, or 256B.092; and

10.4 (7) the person's right to appeal the decision regarding the need for nursing facility
10.5 level of care or the county's final decisions regarding public programs eligibility according
10.6 to section 256.045, subdivision 3.

10.7 (i) Face-to-face assessment completed as part of eligibility determination for
10.8 the alternative care, elderly waiver, community alternatives for disabled individuals,
10.9 community alternative care, and traumatic brain injury waiver programs under sections
10.10 256B.0915, 256B.0917, and 256B.49 is valid to establish service eligibility for no more
10.11 than 60 calendar days after the date of assessment. The effective eligibility start date
10.12 for these programs can never be prior to the date of assessment. If an assessment was
10.13 completed more than 60 days before the effective waiver or alternative care program
10.14 eligibility start date, assessment and support plan information must be updated in a
10.15 face-to-face visit and documented in the department's Medicaid Management Information
10.16 System (MMIS). The effective date of program eligibility in this case cannot be prior to
10.17 the date the updated assessment is completed.

10.18 Sec. 2. Minnesota Statutes 2011 Supplement, section 256B.0915, subdivision 3e,
10.19 is amended to read:

10.20 Subd. 3e. **Customized living service rate.** (a) Payment for customized living
10.21 services shall be a monthly rate authorized by the lead agency within the parameters
10.22 established by the commissioner. The payment agreement must delineate the amount of
10.23 each component service included in the recipient's customized living service plan. The
10.24 lead agency, with input from the provider of customized living services, shall ensure that
10.25 there is a documented need within the parameters established by the commissioner for all
10.26 component customized living services authorized.

10.27 (b) The payment rate must be based on the amount of component services to be
10.28 provided utilizing component rates established by the commissioner. Counties and tribes
10.29 shall use tools issued by the commissioner to develop and document customized living
10.30 service plans and rates.

10.31 (c) Component service rates must not exceed payment rates for comparable elderly
10.32 waiver or medical assistance services and must reflect economies of scale. Customized
10.33 living services must not include rent or raw food costs.

10.34 (d) With the exception of individuals described in subdivision 3a, paragraph (b), the
10.35 individualized monthly authorized payment for the customized living service plan shall

11.1 not exceed 50 percent of the greater of either the statewide or any of the geographic
11.2 groups' weighted average monthly nursing facility rate of the case mix resident class
11.3 to which the elderly waiver eligible client would be assigned under Minnesota Rules,
11.4 parts 9549.0050 to 9549.0059, less the maintenance needs allowance as described
11.5 in subdivision 1d, paragraph (a), until the July 1 of the state fiscal year in which the
11.6 resident assessment system as described in section 256B.438 for nursing home rate
11.7 determination is implemented. Effective on July 1 of the state fiscal year in which
11.8 the resident assessment system as described in section 256B.438 for nursing home
11.9 rate determination is implemented and July 1 of each subsequent state fiscal year, the
11.10 individualized monthly authorized payment for the services described in this clause shall
11.11 not exceed the limit which was in effect on June 30 of the previous state fiscal year
11.12 updated annually based on legislatively adopted changes to all service rate maximums for
11.13 home and community-based service providers.

11.14 (e) Effective July 1, 2011, the individualized monthly payment for the customized
11.15 living service plan for individuals described in subdivision 3a, paragraph (b), must be the
