1.7 1.8	Section 1. Minnesota Statutes 2016, section 256B.0915, subdivision 1d, is amended to read:
1.9	Subd. 1d. Posteligibility treatment of income and resources for elderly waiver.
1.10	Notwithstanding the provisions of section 256B.056, the commissioner shall make the
1.11	following amendment to the medical assistance elderly waiver program effective July 1,
1.12	1999, or upon federal approval, whichever is later.
1.13	A recipient's maintenance needs will be an amount equal to the Minnesota supplemental
1.14	aid equivalent rate as defined in section 256I.03, subdivision 5, plus the medical assistance
1.15	personal needs allowance and supplemental personal needs allowance as defined in section
1.16	256B.35, subdivision 1, paragraph (a), and subdivision 1a, when applying posteligibility
1.17	treatment of income rules to the gross income of elderly waiver recipients, except for
1.18	individuals whose income is in excess of the special income standard according to Code of
1.19	Federal Regulations, title 42, section 435.236. Recipient maintenance needs shall be adjusted
