1.7	Section 1. Minnesota Statutes 2018, section 136F.58, is amended by adding a subdivision
1.8	to read:
1.9	Subd. 1a. Definitions. (a) For purposes of this section, the following terms have the
1.10	meanings given.
1.11	(b) "Custom textbook" means course materials that are compiled by a publisher at the
1.12	direction of a faculty member or, if applicable, the other adopting entity in charge of selecting
1.13	course materials for courses taught at a state college or university. Custom textbooks may
1.14	include items such as selections from original instructor materials, previously copyrighted
1.15	publisher materials, copyrighted third-party works, or elements unique to a specific state
1.16	college or university.
1.17	(c) "Incentive" means anything provided to encourage the use of open textbooks,
1.18	including but not limited to financial compensation.
1.19	(d) "Open textbook" means a textbook that is distributed using an open copyright license
1.20	that at a minimum allows a student to obtain, retain, reuse, and redistribute the material at
1.21	no cost.
1.22	(e) "System office" means the Minnesota State Colleges and Universities system office.
