1.2 relating to public safety; creating a civil cause of action for the nonconsensual
1.3 dissemination of private sexual images and nonconsensual sexual solicitation;
1.4 amending the crime of coercion to include threat of nonconsensual dissemination
1.5 of private sexual images; amending the crime of stalking to include
1.6 nonconsensual sexual solicitation; expanding the definitions of qualified domestic
1.7 violence-related offense and harassment; establishing criminal penalties for
1.8 nonconsensual dissemination of private sexual images and nonconsensual sexual
1.9 solicitation; clarifying the law of criminal defamation; amending Minnesota
1.10 Statutes 2014, sections 609.02, subdivision 16; 609.27, subdivision 1; 609.275;
1.11 609.748, subdivision 1; 609.749, subdivision 2; 609.765; Minnesota Statutes
1.12 2015 Supplement, section 628.26; proposing coding for new law in Minnesota
1.13 Statutes, chapters 604; 617.

1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. [604.30] DEFINITIONS.

1.16 (a) For the purposes of sections 604.30 and 604.31, the following terms have the
1.17 meanings given.

1.18 (b) "Dissemination" means distribution to one or more persons, other than the person
1.19 who is depicted in the image, or publication by any publicly available medium.

1.20 (c) "Image" means a photograph, film, video recording, or digital photograph
1.21 or recording.

1.22 (d) "Intimate parts" means genitals, pubic area, or anus of an individual, or if the
1.23 individual is female, a partially or fully exposed nipple.

1.24 (e) "Personal information" includes any identifier that permits physical contact or
1.25 communication with the person depicted in the image, including:

1.26 (1) the person's first and last name, first initial and last name, or first name and
1.27 last initial;

1.28 (2) the person's home, school, or work address;

2.1 (3) the person's telephone number, e-mail address, or social media account
2.2 information; or

2.3 (4) the person's geolocation data.

2.4 (f) "Sexual act" means either sexual contact or sexual penetration.

2.5 (g) "Sexual contact" means the intentional touching of another's intimate parts or
2.6 intentional touching with seminal fluid or sperm onto another person's body.

2.7 (h) "Social media" means any electronic medium, including an interactive computer
2.8 service, telephone network, or data network, that allows users to create, share, and view
2.9 user-generated content.

2.10 (i) "Sexual penetration" means any of the following acts:

2.11 (1) sexual intercourse, cunnilingus, fellatio, or anal intercourse; or

2.12 (2) any intrusion, however slight, into the genital or anal openings of an individual
2.13 by another's body part or an object used by another for this purpose.

2.14 **Sec. 2. [604.31] CAUSE OF ACTION FOR NONCONSENSUAL**
2.15 **DISSEMINATION OF PRIVATE SEXUAL IMAGES; SEXUAL SOLICITATION.**

2.16 Subdivision 1. **Nonconsensual dissemination of private sexual images.** (a) A
2.17 cause of action against a person for the nonconsensual dissemination of private sexual
2.18 images exists when:

2.19 (1) a person disseminated an image without the consent of the person depicted
2.20 in the image;

2.21 (2) the image is of an individual engaged in a sexual act or whose intimate parts
2.22 are exposed in whole or in part;

2.23 (3) the person is identifiable:

2.24 (i) from the image itself, by the person depicted in the image or by another person; or

2.25 (ii) from the personal information displayed in connection with the image; and

2.26 (4) the image was obtained or created under circumstances in which a reasonable
2.27 person would know or understand that the image was to remain private.

2.28 (b) The fact that the individual depicted in the image consented to the creation of the
2.29 image or to the voluntary private transmission of the image is not a defense to liability for
2.30 a person who has disseminated the image without consent.

2.31 Subd. 2. **Nonconsensual sexual solicitation.** A person who uses the personal
2.32 information of another to invite, encourage, or solicit sexual acts without the individual's
2.33 consent and knows or has reason to know it will cause the person whose personal
2.34 information is used to feel harassed, frightened, threatened, oppressed, persecuted, or

3.1 intimidated, is liable for damages to the individual whose personal information was
3.2 published or disseminated publicly.

3.3 Subd. 3. **Damages.** The court may award the following damages to a prevailing
3.4 plaintiff from a person found liable under subdivision 1 or 2:

3.5 (1) general and special damages, including all financial losses due to the
3.6 dissemination of the image and damages for mental anguish;

3.7 (2) an amount equal to any profit made from the dissemination of the image by the
3.8 person who intentionally disclosed the image;

3.9 (3) a civil penalty awarded to the plaintiff of an amount up to \$10,000; and

3.10 (4) court costs, fees, and reasonable attorney fees.

3.11 Subd. 4. **Injunction; temporary relief.** (a) A court may issue a temporary or
3.12 permanent injunction or restraining order to prevent further harm to the plaintiff.

3.13 (b) The court may issue a civil fine for the violation of a court order in an amount up
3.14 to \$1,000 per day for failure to comply with an order granted under this section.

3.15 Subd. 5. **Confidentiality.** The court shall allow confidential filings to protect the
3.16 privacy of the plaintiff in cases filed under this section.

3.17 Subd. 6. **Liability; exceptions.** (a) No person shall be found liable under this
3.18 section when:

3.19 (1) the dissemination is made for the purpose of a criminal investigation or
3.20 prosecution that is otherwise lawful;

3.21 (2) the dissemination is for the purpose of, or in connection with, the reporting of
3.22 unlawful conduct;

3.23 (3) the dissemination is made in the course of seeking or receiving medical
3.24 treatment, and the image is protected from further distribution;

3.25 (4) the image involves voluntary exposure in a public or was obtained in a
3.26 commercial setting for the purpose of the legal sale of goods or services, including the
3.27 creation of artistic products for sale or display;

3.28 (5) the image relates to a matter of public interest and dissemination serves a lawful
3.29 public purpose;

3.30 (6) the dissemination is for legitimate scientific research or educational purposes; or

3.31 (7) the dissemination is made for legal proceedings and is consistent with common
3.32 practice in civil proceedings, necessary for the proper functioning of the criminal justice
3.33 system, or protected by court order which prohibits any further dissemination.

3.34 (b) This section does not alter or amend the liabilities and protections granted by
3.35 United States Code, title 47, section 230, and shall be construed in a manner consistent
3.36 with federal law.

4.1 (c) A cause of action arising under this section does not prevent the use of any other
4.2 cause of action or remedy available under the law.

4.3 Subd. 7. **Jurisdiction.** A court has jurisdiction over a cause of action filed pursuant
4.4 to this section if the plaintiff or respondent resides in this state.

4.5 Subd. 8. **Venue.** A cause of action arising under this section may be filed in either:

4.6 (1) the county of residence of the respondent or plaintiff or in the jurisdiction of the
4.7 plaintiff's designated address if the plaintiff participates in the address confidentiality
4.8 program established by chapter 5B; or

4.9 (2) the county where any image is produced, reproduced, or stored in violation
4.10 of this section.

4.11 Subd. 9. **Discovery of dissemination.** In a civil action brought under subdivision
4.12 1, the statute of limitations is tolled until the plaintiff discovers the image has been
4.13 disseminated.

4.14 **EFFECTIVE DATE.** This section is effective August 1, 2016, and applies to causes
4.15 of action commenced on or after that date.

5.23 coerce and may be punished as provided in section 609.17.

5.24 **EFFECTIVE DATE.** This section is effective August 1, 2016, and applies to crimes

6.7 harassment or organizations alleged to have sponsored or promoted harassment.

6.8 (c) "Targeted residential picketing" includes the following acts when committed on
6.9 more than one occasion:

6.10 (1) marching, standing, or patrolling by one or more persons directed solely at a
6.11 particular residential building in a manner that adversely affects the safety, security, or
6.12 privacy of an occupant of the building; or

6.13 (2) marching, standing, or patrolling by one or more persons which prevents an
6.14 occupant of a residential building from gaining access to or exiting from the property on
6.15 which the residential building is located.

6.18 Subd. 2. **Stalking crimes.** A person who stalks another by committing any of the
6.19 following acts is guilty of a gross misdemeanor:

6.20 (1) directly or indirectly, or through third parties, manifests a purpose or intent to
6.21 injure the person, property, or rights of another by the commission of an unlawful act;

6.22 (2) follows, monitors, or pursues another, whether in person or through any available
6.23 technological or other means;

6.24 (3) returns to the property of another if the actor is without claim of right to the
6.25 property or consent of one with authority to consent;

6.26 (4) repeatedly makes telephone calls, sends text messages, or induces a victim to
6.27 make telephone calls to the actor, whether or not conversation ensues;

6.28 (5) makes or causes the telephone of another repeatedly or continuously to ring;

6.29 (6) repeatedly mails or delivers or causes the delivery by any means, including
6.30 electronically, of letters, telegrams, messages, packages, through assistive devices for

7.3 For purposes of this clause, "personal information" and "sexual act" have the meanings
 7.4 given in section 617.261, subdivision 7.

7.5 **EFFECTIVE DATE.** This section is effective August 1, 2016, and applies to crimes
 7.6 committed on or after that date.

7.7 Sec. 8. Minnesota Statutes 2014, section 609.765, is amended to read:

7.8 **609.765 CRIMINAL DEFAMATION.**

7.9 Subdivision 1. **Definition.** Defamatory matter is anything which exposes a person
 7.10 or a group, class or association to hatred, contempt, ridicule, degradation or disgrace in
 7.11 society, or injury to business or occupation.

7.12 Subd. 2. **Acts constituting.** Whoever with knowledge of its false and defamatory
 7.13 character orally, in writing or by any other means, communicates any false and defamatory
 7.14 matter to a third person without the consent of the person defamed is guilty of criminal
 7.15 defamation and may be sentenced to imprisonment for not more than one year or to
 7.16 payment of a fine of not more than \$3,000, or both.

7.17 Subd. 3. **Justification.** Violation of subdivision 2 is justified if:

7.18 (1) ~~the defamatory matter is true and is communicated with good motives and for~~
 7.19 ~~justifiable ends; or~~

8.2 SEXUAL IMAGES.

8.3 Subdivision 1. **Crime.** It is a crime to intentionally disseminate an image of another
8.4 person who is engaged in a sexual act or whose intimate parts are exposed, in whole or
8.5 in part, when:

8.6 (1) the person is identifiable:

8.7 (i) from the image itself, by the person depicted in the image or by another person; or

8.8 (ii) from personal information displayed in connection with the image;

8.9 (2) the actor knows or should know that the person depicted in the image does not
8.10 consent to the dissemination; and

8.11 (3) the image was obtained or created under circumstances in which a reasonable
8.12 person would know or understand that the image was to remain private.

8.13 Subd. 2. **Penalties; aggravating factors.** (a) Except as provided in paragraphs (b)
8.14 and (c), whoever violates subdivision 1 is guilty of a gross misdemeanor.

8.15 (b) Whoever violates subdivision 1 may be sentenced to imprisonment for not
8.16 more than three years or to payment of a fine of \$5,000, or both, if one of the following
8.17 aggravating factors is present:

8.18 (1) the person depicted in the image suffers financial loss due to the dissemination
8.19 of the image;

8.20 (2) the actor disseminates the image with intent to profit from the dissemination;

8.21 (3) the actor maintains a Web site, online service, online application, or mobile
8.22 application for the purpose of disseminating the image;

8.23 (4) the actor posts the image on a Web site;

8.30 than seven years or to payment of a fine of \$15,000, or both, if either:

8.32 older than the minor and one of the aggravating factors in paragraph (b) is present; or

8.33 (2) two or more aggravating factors in paragraph (b) are present.

8.34 Subd. 3. **Reasonable expectation of privacy.** For purposes of subdivision 1, clause
8.35 (3), a person who, within the context of a private or confidential relationship, consented to
8.36 the capture or possession of an image involving engaging in a sexual act or exposure of

9.2 of the image beyond that relationship.

10.30 **EFFECTIVE DATE.** This section is effective August 1, 2016, and applies to crimes
10.31 committed on or after that date.

10.32 Sec. 10. Minnesota Statutes 2015 Supplement, section 628.26, is amended to read:

10.33 **628.26 LIMITATIONS.**

11.1 (a) Indictments or complaints for any crime resulting in the death of the victim may
11.2 be found or made at any time after the death of the person killed.

11.3 (b) Indictments or complaints for a violation of section 609.25 may be found or
11.4 made at any time after the commission of the offense.

11.5 (c) Indictments or complaints for violation of section 609.282 may be found or made
11.6 at any time after the commission of the offense if the victim was under the age of 18 at
11.7 the time of the offense.

11.8 (d) Indictments or complaints for violation of section 609.282 where the victim
11.9 was 18 years of age or older at the time of the offense, or 609.42, subdivision 1, clause
11.10 (1) or (2), shall be found or made and filed in the proper court within six years after
11.11 the commission of the offense.

12.9 ~~(m)~~ (n) The limitations periods contained in this section for an offense shall not
12.10 include any period during which the alleged offender participated under a written
12.11 agreement in a pretrial diversion program relating to that offense.

12.12 ~~(n)~~ (o) The limitations periods contained in this section shall not include any period
12.13 of time during which physical evidence relating to the offense was undergoing DNA
12.14 analysis, as defined in section 299C.155, unless the defendant demonstrates that the
12.15 prosecuting or law enforcement agency purposefully delayed the DNA analysis process in
12.16 order to gain an unfair advantage.

12.17 **EFFECTIVE DATE.** This section is effective August 1, 2016, and applies to crimes
12.18 committed on or after that date.
