(7) "Personal representative" means the executor, administrator or other person 4.11 appointed by the court to administer and dispose of the property of the decedent. If there 4.12 is no executor, administrator or other person appointed, qualified, and acting within this 4.13 state, then any person in actual or constructive possession of any property having a situs in 4.14 this state which is included in the federal gross estate of the decedent shall be deemed 4.15 to be a personal representative to the extent of the property and the Minnesota estate tax 4.16 due with respect to the property. 4.17
