1.6	Section 1. [3.8845] LEGISLATIVE COMMISSION ON STATE INFORMATION
1.7	TECHNOLOGY SERVICES.
1.8	Subdivision 1. Established. The Legislative Commission on State Information
1.9	Technology Services is established to oversee the work of the Office of MN.IT Services
1.10	and the information technology infrastructure, spending, and security programs of state
1.11	agencies.
1.12	Subd. 2. Membership. The commission consists of four senators appointed by the senate
1.13	Subcommittee on Committees of the Committee on Rules and Administration and four
1.14	members of the house of representatives appointed by the speaker of the house. Two members
1.15	from each chamber must be from the majority party in that chamber, and two members from
1.16	each chamber must be from the minority party in that chamber. Each appointing authority
1.17	must make appointments as soon as possible after the beginning of the regular legislative
1.18	session in the odd-numbered year. In making appointments, priority must be given to
1.19	members with a demonstrated interest in or a history of working in information technology
1.20	or related fields.
1.21	Subd. 3. Terms; vacancies. Members of the commission serve for terms beginning upon
1.22	appointment and ending at the beginning of the regular legislative session in the next

3.1	(b) A copy of all recommendations adopted by the commission, regardless of the entity
3.2	to which the recommendation is directed, must be submitted to the chairs and ranking
3.3	minority members of the legislative committees with jurisdiction over state government
3.4	finance within 30 days of the recommendations' adoption.
3.5	Subd. 8. Expiration. The commission expires June 30, 2021.
3.6	EFFECTIVE DATE. This section is effective the day following final enactment. Initial
3.7	appointments to the commission must be made no later than July 1, 2018. The ranking
3.8	representative from the majority party must convene the first meeting of the commission
3.9	no later than August 1, 2018.
