1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2016, section 245C.03, is amended by adding a subdivision
1.8	to read:
1.9	Subd. 13. Minor children background studies. For a minor affiliated with a child care
1.10	program, after receiving the privacy notice in section 245C.05, subdivision 2c, a parent may
1.11	opt to have the required background study for a child include the submission of a child's
1.12	fingerprints for a national criminal history record check as part of the review of information
1.13	under section 245C.08 if a child:
1.14	(1) is 13 to 17 years of age; and
1.15	(2) resides with a legal nonlicensed child care provider authorized under chapter 119B
1.16	or at a licensed family child care program.
1.17	A child's background study conducted under this subdivision is valid for five years.
1.18	<b>EFFECTIVE DATE.</b> This section is effective upon implementation of NETStudy 2.0
1.19	for family child care programs. The commissioner of human services shall notify the revisor

- (a) A background study subject may request in writing to the commissioner that 5.1 information used to complete the individual's study in NETStudy 2.0 be destroyed if the 5.2 individual: 5.3
- (1) has not been affiliated with any entity for the previous two years; and 5.4
- 5.5 (2) has no current disqualifying characteristic.
- (b) After receiving the request and verifying the information in paragraph (a), the 5.6
- commissioner shall destroy the information used to complete the subject's background study 5.7
- and shall keep a record of the subject's name and a notation of the date that the information 5.8
- was destroyed. The commissioner shall notify the study subject when the information used 5.9
- to complete the subject's background study is destroyed. 5.10

## Sec. 5. DIRECTION TO COMMISSIONER; UNIFYING BACKGROUND STUDIES.

- (a) The commissioner of human services shall work with stakeholders and affected 5.20
- agencies and boards to unify the background studies process required by the Departments 5.21
- of Human Services and Health, health-related licensing board as defined in Minnesota 5.22
- Statutes, section 214.01, subdivision 2, and Professional Educator Licensing and Standards 5.23
- Board as defined in Minnesota Statutes, section 122A.06, subdivision 3, to: 5.24
- (1) establish a single background study process that satisfies the requirements for all 5.25
- background studies required by the Departments of Human Services and Health, 5.26
